~~(C) (D) UPON RECEIPT OF THE PROPOSED FOREST CONSERVATION PLAN, THE STATE OR LOCAL AUTHORITY SHALL HAVE 10 WORKING DAYS TO ISSUE A NOTICE TO THE APPLICANT THAT THE SUBMITTAL REQUIREMENTS HAVE BEEN MET. THIS NOTICE DOES NOT CONSTITUTE NOTICE THAT THE PROPOSED FOREST CONSERVATION PLAN IS APPROVED.~~

(D) WITHIN 45 DAYS FROM RECEIPT OF THE FOREST CONSERVATION PLAN, THE DEPARTMENT OR LOCAL AUTHORITY SHALL NOTIFY THE APPLICANT WHETHER THE FOREST CONSERVATION PLAN IS COMPLETE AND APPROVED. IF THE DEPARTMENT OR LOCAL AUTHORITY FAILS TO NOTIFY THE APPLICANT ABOUT THE FOREST CONSERVATION PLAN WITHIN 45 DAYS, THE PLAN SHALL BE TREATED AS COMPLETE AND APPROVED. THE DEPARTMENT OR LOCAL AUTHORITY MAY REQUIRE FURTHER INFORMATION OR PROVIDE FOR AN EXTENSION OF THIS DEADLINE FOR AN ADDITIONAL 15
