- (4) WITHHOLDING WITHHOLD ANY DOCUMENT FROM A RECEIVER, TRUSTEE, OR OTHER OFFICER OF A COURT ENTITLED TO ITS POSSESSION PURSUANT TO SUBTITLE 10 OF THIS ARTICLE; OR
- (5) GIVING, OBTAINING, OR RECEIVING GIVE, OBTAIN, OR RECEIVE ANYTHING OF VALUE FOR ACTING OR FORBEARING TO ACT IN ANY PROCEEDING PURSUANT TO SUBTITLE 10 OF THIS ARTICLE.
- (D) (1) ANY PERSON WHO VIOLATES SUBSECTION (B) OF THIS SECTION IS GUILTY OF A MISDEMEANOR AND UPON CONVICTION SHALL BE PUNISHED BY A FINE OF NOT MORE THAN \$50,000 OR BY IMPRISONMENT FOR A PERIOD OF NOT MORE THAN 1 YEAR OR BOTH SHALL BE SUBJECT TO A CIVIL PENALTY OF NOT MORE THAN \$50,000 IN ADDITION TO ANY OTHER APPLICABLE PENALTIES IN THIS ARTICLE.
- (2) ANY PERSON WHO VIOLATES SUBSECTION (C) OF THIS SECTION IS GUILTY OF A FELONY MISDEMEANOR AND UPON CONVICTION SHALL BE PUNISHED BY A FINE OF NOT MORE THAN \$50,000 OR BY IMPRISONMENT FOR A PERIOD OF NOT MORE THAN \$ 3 YEARS OR BOTH IN ADDITION TO ANY OTHER APPLICABLE PENALTIES IN THIS ARTICLE.
- (3) THE COMMISSIONER MAY IMPOSE THE PENALTIES SPECIFIED IN § 215 OF THIS ARTICLE ON PERSONS FOUND IN VIOLATION OF SUBSECTION (B) OR (C) OF THIS SECTION.
- (E) ANY NOTIFICATION PROVIDED TO THE COMMISSIONER UNDER THIS SECTION SHALL BE GIVEN CONFIDENTIAL TREATMENT IN ACCORDANCE WITH § 499 OF THIS ARTICLE.
