~~(II) 1. IF A PERSON IS SUBJECT TO THE FINE UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH, THE COURT MAY ORDER THE MOTOR VEHICLE ADMINISTRATION TO SUSPEND THE PERSON'S DRIVING PRIVILEGE FOR 6 MONTHS FOR THE FIRST OFFENSE OR UNTIL THE PERSON IS 21 YEARS OLD FOR THE SECOND OFFENSE.~~

~~2. (II) IF THE A PERSON SUBJECT TO SUSPENSION UNDER THIS SUBPARAGRAPH DOES NOT HOLD A LICENSE TO OPERATE A MOTOR VEHICLE ON THE DATE OF THE DISPOSITION, THE SUSPENSION SHALL COMMENCE ON THE DATE THE PERSON APPLIES AND BECOMES QUALIFIED TO RECEIVE A LICENSE.~~
