

(5) A DEVELOPER, BUILDER, OR CONTRACTOR TO PROVIDE CUSTOMARY AND USUAL SERVICES, INCLUDING CONTRACTING FOR DESIGN SERVICES RELATED TO THE DEVELOPER'S, BUILDER'S, OR CONTRACTOR'S OWN CONSTRUCTION OF NEW OR EXISTING SINGLE-FAMILY OR TWO-FAMILY DWELLINGS, OR STRUCTURES ANCILLARY TO THEM, OR FARM BUILDINGS.

(C) SUBJECT TO SUBSECTION (B)(5) OF THIS SECTION, A DEVELOPER, BUILDER, CONTRACTOR, OR OTHER PERSON MAY NOT PROVIDE, ATTEMPT TO PROVIDE, OR MAKE REPRESENTATIONS OF BEING QUALIFIED TO PROVIDE ARCHITECTURAL SERVICES TO OTHERS IN CONNECTION WITH THE ALTERATION, CONSTRUCTION, DESIGN, OR REPAIR OF A BUILDING OR OTHER STRUCTURE THAT:

(1) IS FOR PERSONAL USE; AND

(2) IS NOT INTENDED FOR ANY PUBLIC USE, INCLUDING ASSEMBLY, EMPLOYMENT, OR OCCUPANCY.

(C) SERVICES PROVIDED IN ACCORDANCE WITH SUBSECTION (B)(5) OF THIS SECTION DO NOT REQUIRE AN ARCHITECT'S SEAL.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1991.

CHAPTER 457

(House Bill 265)

AN ACT concerning

Alcoholic Beverages – False Age Identification – Penalty Suspension of License

FOR the purpose of altering the penalty for certain minors who have used a false age identification for the purpose of fraudulently buying or receiving alcoholic beverages; authorizing the court to order that the minor's driving privilege be suspended for a certain period of time and that the minor participate in community work programs for a certain number of hours under certain circumstances; providing certain driving suspension exceptions; making stylistic changes; and generally relating to the penalty for certain minors who fraudulently buy or receive alcoholic beverages through the use of false age identification.

FOR the purpose of requiring the Motor Vehicle Administration to suspend the license of adults of certain ages for certain Code violations concerning alcoholic beverages that involved the use of a driver's license or a document purporting to be a driver's license; altering the periods of suspension applicable to minors who commit certain Code violations concerning alcoholic beverages under certain circumstances;
