- (3) After the annual audit of each community college, any discrepancy between the payments made and the actual State share under [§]§ 16-403[, 16-403.1, and 16-403.2] of this subtitle for the preceding fiscal year, which shall be compensated for in the November payment.
- (b) Within 5 days after he <u>THE COMPTROLLER</u> receives a certification from the State Board for Community Colleges, the State Comptroller shall draw a warrant on the State Treasurer for the amount due each [community college] BOARD OF TRUSTEES. The State Treasurer immediately shall pay the amount due to the board of trustees of the community college.

- (a) (2) (i) A resident of the state of West Virginia who attends Garrett Community College under a negotiated reciprocity agreement between the states of Maryland and West Virginia is an in-county resident for tuition purposes.
- (ii) For each full-time equivalent student participating in the reciprocity agreement, the State shall pay to Garrett Community College an amount equal to the net State support per full-time equivalent student as provided in [§]§ 16-403 [and 16-403.1] of this subtitle.
- (iii) The State Board for Community Colleges may make payments to effectuate the provisions of this paragraph from funds specifically appropriated for this purpose as provided in the State budget or any supplemental budget request.
- (IV) THE PAYMENTS AUTHORIZED BY THIS PARAGRAPH ARE IN ADDITION TO THE STATE OPERATING FUND APPROPRIATION TO COMMUNITY COLLEGES AUTHORIZED IN § 16-403(C) § 16-403(B) OF THIS SUBTITLE.

- [(a)] Except as otherwise provided in this subtitle, the provisions of SUBTITLE 4 OF THIS TITLE AND $\S\S$ 16-201, 16-202, 16-203, 16-204, AND 16-206[, 16-401, 16-402, 16-406, 16-407, 16-408, 16-409, and 16-410] of this article do not apply to the College.
- [(b) Beginning in Fiscal Year 1992 and except as otherwise provided in this subtitle, the provisions of §§ 16–403, 16–403.1, 16–403.2, 16–404, and 16–405 do not apply to the College.]
- SECTION 4. AND BE IT FURTHER ENACTED, That for Fiscal Year 1993, the funds available for the fixed costs component shall be divided and distributed among the community colleges in the same proportion that the total State operating fund appropriation for community colleges, excluding any appropriation provided under § 16–407(a)(2) of the Education Article, was distributed to the community colleges for Fiscal Year 1992. For purposes of this section, the total State operating fund appropriation for community colleges consists of the total State share for the per pupil grant, annual grant, and supplemental program funding for Fiscal Year 1992.
