

to \$5,000,000 \$6,000,000 may be appropriated by approved budget amendment to budget program 36.01.02.03, Aid for Local Employee Fringe Benefits. Receipts in excess of \$5,000,000 \$6,000,000 shall be credited to the General Fund.

SECTION ~~15-~~ 14. AND BE IT FURTHER ENACTED, That, notwithstanding any other provision of law and for fiscal year 1992 only, the salaries of positions in the Executive Pay Plan established under § 27(a)(2) of Article 64 may not be increased beyond the lesser of the amount in effect June 30, 1991 or the salary as reduced by the provisions of the Fiscal Year 1992 Budget Bill (House Bill 650), if a position in the Executive Pay Plan becomes vacant during fiscal year 1992, the salary with respect to recruitment shall be established in accordance with the provisions of Article 64A, § 27(a)(2)(v) and (vi) of the Code.

SECTION ~~16-~~ 15. AND BE IT FURTHER ENACTED, That, notwithstanding any other provision of law and for fiscal year 1992 only, salaries of State employees which are determined with reference to the salaries of Baltimore City or county employees shall not be increased from the fiscal year 1991 amount.

SECTION ~~17-~~ 16. AND BE IT FURTHER ENACTED, That in fiscal year 1992, notwithstanding any other provision of law, the Secretary of Transportation may transfer, from the Motorcycle Safety Program Account established under § 16-605 of the Transportation Article to the account of the Transportation Trust Fund established under § 3-216 of the Transportation Article, an amount not to exceed the total of funds remaining in the Motorcycle Safety Program Account on June 30, 1991.

SECTION ~~18-~~ 17. AND BE IT FURTHER ENACTED, That for fiscal year 1992, the Governor, when acting under § 7-213 of the State Finance and Procurement Article, may only reduce appropriations from which funds are distributed under a statutory formula in a manner which reduces allocations to recipients under the formula in proportion to distributions made under the formula.

SECTION ~~19-~~ 18. AND BE IT FURTHER ENACTED, That for fiscal year 1993 only, the Governor shall include an appropriation to the Revenue Stabilization Account of the State Reserve Fund established in § 7-311 of the State Finance and Procurement Article, in an amount equivalent to the unappropriated general fund surplus as of June 30, 1991. This appropriation shall be above and beyond any appropriation required by § 7-311 of the State Finance and Procurement Article as enacted by Section 1 of this Act.

SECTION ~~20-~~ 19. AND BE IT FURTHER ENACTED, That notwithstanding any other provision of law, in fiscal year 1992, the Governor may transfer, by approved budget amendment, up to the entire balance remaining in the Maryland Emergency Medical System Fund established under § 7-313 of the State Finance and Procurement Article to the budget of the Department of Public Safety and Correctional Services for lease payments related to Maryland Emergency Medical Service System helicopter procurement.

SECTION 20. AND BE IT FURTHER ENACTED, That notwithstanding any other provision of law, on or before June 30, 1991, the Governor may transfer up to \$3,200,000 by approved budget amendment from budget program 32.17.01.03, Medical Care Provider Reimbursements to budget program 33.09.00.01, Assistance Payments to provide funds for
