

~~(3) A STATE OWNED OR STATE OPERATED HOSPITAL IS NOT SUBJECT TO THE PRIORITY REQUIREMENTS ESTABLISHED BY THIS SECTION IF ITS VENDING FACILITIES ARE OPERATED BY VOLUNTEERS AND THE NET PROCEEDS OF THE VENDING FACILITY ACCRUE TO THE BENEFIT OF THE HOSPITAL. THE HOSPITAL MAY GRANT THE PRIORITY.~~

(4) PROPERTY CONTROLLED BY THE DEPARTMENT OF GENERAL SERVICES.

(2) IF A FACILITY REQUIRED TO GIVE THE PRIORITY UNDER THIS SECTION HAS VENDING FACILITIES THAT ARE NOT OPERATED BY BLIND PERSONS, THE REQUIREMENTS OF THIS SECTION ARE WAIVED UNTIL THE EARLIER OF:

(I) THE FIRST EXPIRATION OF A CONTRACT BETWEEN THE OPERATOR OF THE VENDING FACILITY AND THE HOSPITAL DEPARTMENT OF GENERAL SERVICES; OR

(II) JUNE 1, 1994.

~~(C)~~ (D) (1) THE DIVISION AND THE DEPARTMENT OF GENERAL SERVICES SHALL ADOPT REGULATIONS FOR:

(I) THE OPERATION AND MAINTENANCE OF A VENDING FACILITY BY THE PROGRAM; AND FOR

(II) THE PROTECTION OF STATE PROPERTY.

~~(2) THE DIVISION SHALL COOPERATE WITH THE DEPARTMENT OF GENERAL SERVICES~~ THE DEPARTMENT OF GENERAL SERVICES SHALL COOPERATE WITH THE DIVISION FOR THE ESTABLISHMENT, WHENEVER POSSIBLE, OF VENDING FACILITIES OPERATED BY BLIND PERSONS ~~THE PROGRAM ON PUBLIC DEPARTMENT OF GENERAL SERVICES~~ PROPERTY.

~~(4) THE DIVISION SHALL COOPERATE WITH THE STATE DEPARTMENT OF TRANSPORTATION FOR THE OPERATION BY BLIND PERSONS OF VENDING FACILITIES AND FOR THE INSTALLATION OF VENDING MACHINES AT REST AREAS ON HIGHWAYS IN THE STATE. THE PROCEEDS FROM THE VENDING MACHINES SHALL ACCRUE TO THE BLIND PERSON OPERATING THE VENDING FACILITY AT THE REST AREA.~~
