## Article 41 - Governor - Executive and Administrative Departments

8-102.

(a) The following departments, agencies, boards, commissions, offices, divisions, and units of the State government shall be included within the Department of Licensing and Regulation: the State Athletic Commission, the Banking Board, the Bank Commissioner, the Board of Savings and Loan Association Commissioners, the Division of Savings and Loan Associations, the State of Maryland Deposit Insurance Fund Corporation, the Maryland Home Improvement Commission, the Insurance Division, the Commissioner of Consumer Credit, the Maryland Racing Commission, Maryland-Bred Race Fund Advisory Committee, the State Real Estate Commission, the Real Estate Hearing Board, the Board of Boiler Rules, the State Board of Barbers, the State Board of Examining Engineers, the State Board of Master Electricians, the State Board of Plumbing, the State Board of Architects, the State Board of Cosmetologists, the State Board for Professional Engineers, the State Board for Professional Land Surveyors, the State Board of Public Accountancy, the State Board of Pilots, the Division of Labor and Industry, the Office of Commissioner of Labor and Industry, the Advisory Council on Prevailing Wage Rates, the Advisory Committee on the Wage and Hour Law, the Occupational Safety and Health Advisory Board, the Employment Agency Advisory Board, the State Board of Examiners of Landscape Architects, the State Board of Foresters, the State Board of Examiners for Hearing Aid Dealers, the State Commission of Real Estate Appraisers, THE STATE BOARD OF CERTIFIED INTERIOR DESIGNERS, and such other agencies, boards, commissions, councils, offices, or units of government as may hereafter pursuant to law be declared to be part of the Department of Licensing and Regulation.

## Article - State Government

8-403.

- (G) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION (E) OF THIS SECTION, ON OR BEFORE JULY 1, 1996, AN EVALUATION SHALL BE MADE OF THE STATE BOARD OF CERTIFIED INTERIOR DESIGNERS ESTABLISHED UNDER THE BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE AND THE REGULATIONS THAT RELATE TO THE STATE BOARD OF CERTIFIED INTERIOR DESIGNERS.
- SECTION 2. AND BE IT FURTHER ENACTED, That the Governor shall appoint 2 of the initial interior designer members of the Board for terms of 1 year, 2 of the initial interior designer members of the Board for terms of 2 years, and 1 of the initial interior designer members of the Board for a term of 3 years, the initial consumer member of the Board for a term of 2 years, and the initial architect member for a term of 1 year.
- SECTION 3. AND BE IT FURTHER ENACTED, That each interior designer member of the Board who is appointed before the Board begins to certify interior designers and who has provided interior design services for at least 5 years before appointment shall be considered to be certified for purposes of appointment as a member of the Board.
