~~(A) IN BALTIMORE COUNTY, EXCEPT AS OTHERWISE PROVIDED IN THIS ARTICLE, A PERSON SHALL OBTAIN A SPECIAL NO SALE BRING AND CONSUME ALCOHOLIC BEVERAGES PERMIT BEFORE OPERATING A BUSINESS ESTABLISHMENT THAT:~~

~~(1) IS OPEN TO THE PUBLIC; AND~~

~~(2) ALLOWS PATRONS TO BRING AND CONSUME ALCOHOLIC BEVERAGES ON THE ESTABLISHMENT'S PREMISES.~~

~~(B) THE BALTIMORE COUNTY BOARD OF LICENSE COMMISSIONERS MAY ISSUE A SPECIAL NO SALE BRING AND CONSUME ALCOHOLIC BEVERAGES PERMIT IN BALTIMORE COUNTY FOR USE ON THE PREMISES OF A BUSINESS ESTABLISHMENT THAT IS OPEN TO THE PUBLIC.~~

~~(C) NOTWITHSTANDING ANY OTHER PROVISION TO THE CONTRARY, THE SPECIAL NO SALE BRING AND CONSUME ALCOHOLIC BEVERAGES PERMIT AUTHORIZES:~~

~~(1) THE HOLDER TO ADMIT ON THE PREMISES PATRONS OF DRINKING AGE WHO BRING ALCOHOLIC BEVERAGES FOR THEIR OWN CONSUMPTION; AND~~

~~(2) PATRONS TO CONSUME THE ALCOHOLIC BEVERAGES ON THE PREMISES ONLY.~~

~~(D) THE SPECIAL NO SALE BRING AND CONSUME ALCOHOLIC BEVERAGES PERMIT:~~

~~(1) MAY NOT BE ISSUED FOR USE ON ANY PREMISES LICENSED TO SELL ALCOHOLIC BEVERAGES UNDER THIS ARTICLE; AND~~

~~(2) DOES NOT AUTHORIZE THE HOLDER TO BUY, SELL, STORE, DISPENSE, OR SERVE ALCOHOLIC BEVERAGES ON THE PREMISES.~~

~~(E) A SPECIAL NO SALE BRING AND CONSUME ALCOHOLIC BEVERAGES PERMIT IS ISSUABLE IN ONE OF THE FOLLOWING 3 CLASSES:~~

~~(1) CLASS 1 BEER PERMIT;~~

~~(2) CLASS 2 BEER AND WINE PERMIT; OR~~

~~(3) CLASS 3 BEER, WINE AND LIQUOR PERMIT.~~

~~(F) UNLESS THE BOARD OF LICENSE COMMISSIONERS PROVIDES OTHERWISE, THE HOURS AND DAYS FOR CONSUMPTION UNDER THE PERMIT ARE THE SAME AS THE HOURS AND DAYS FOR THE SALE OF ALCOHOLIC BEVERAGES UNDER THE RESPECTIVE CLASS B LICENSE IN BALTIMORE COUNTY.~~
