CHARTER AMENDMENT RESOLUTION 90–4

A RESOLUTION AMENDING ARTICLE V OF THE CHARTER SO AS TO ELIMINATE THE ELECTION OF COMMISSIONERS BY DISTRICTS, TO PROVIDE THAT THE COMMISSIONERS MAY MODIFY THE HOURS THAT THE POLLS ARE TO REMAIN OPEN, TO PROVIDE FOR ABSENTEE AND WRITE-IN BALLOTS, AND TO PROVIDE FOR UNIVERSAL REGISTRATION.
