AN ACT concerning

Title 34 "Water, Sewers, Sewage Disposal and Drains"

FOR the purpose of repealing sections dealing with the benefit assessment for water and sewer extensions, interim procedure for major water and sewer connections, extinguishment rates, removal of contents of privy boxes, penalty, affect of article on other acts and agreements, repeal of inconsistent provisions, options for servicemen, severability, Towson Sewerage system; repealing and reenacting sections dealing with watersheds, classification of property for assessments of benefits for water and sewer connections, rules and regulations, discharge from sewage treatment plant, use of watertight boxes, overflow of sewage, descriptions of metropolitan district, extension of boundaries of district, sanitary engineer, publication of financial statement for district, acquisition of property, arbitration with Baltimore City, entry upon public roads for installation or maintenance of facilities, right of entry by county employees on private property to clean streams, planning for water and sewerage supply, extension of system if not self-supporting, construction of system by private persons, prior approval of construction plans, unauthorized opening of fire hydrant, notice to connect, when connection not required, plumbing code, duty to connect to system, inspection, failure to connect, right of property owner to choose person to make connection, procedure when owner does not make such choice, interference with county employees, interest on assessed costs, county charge to connect, when payments due, remote property extension, change of classification of property for purposes of rate making, water distribution charge, collection of water charges for Sunnybrook, term of front foot assessment, liens, amortization, identification on tax rolls, preparation of tax bills, authority to adopt legislation, connection by owners not abutting system, benefit charges on irregularly shaped lots, deferral of certain front foot benefit assessments, bonds, acceptance of bids for bonds, retirement of bonds, payment of bond debt service; combination bidding on bond issues and short term borrowing, criminal penalties.
