

EACH AUXILIARY POLICE OFFICER FOR BALTIMORE COUNTY IS A COVERED EMPLOYEE WHILE ON DUTY AS DEFINED IN THE BALTIMORE COUNTY POLICE MANUAL OF RULES, REGULATIONS, AND PROCEDURES.

(B) VOLUNTEER DEPARTMENTS.

(1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, EACH MEMBER OF A VOLUNTEER POLICE DEPARTMENT IS A COVERED EMPLOYEE.

(2) A MEMBER OF A VOLUNTEER POLICE DEPARTMENT IN ALLEGANY, CARROLL, CECIL, CHARLES, FREDERICK, GARRETT, QUEEN ANNE'S, ST. MARY'S, SOMERSET, WASHINGTON, OR WORCESTER COUNTY IS NOT A COVERED EMPLOYEE.

(3) FOR THE PURPOSES OF THIS TITLE, THE POLITICAL SUBDIVISION OF THE STATE WHERE THE DEPARTMENT IS ORGANIZED IS THE EMPLOYER OF THE COVERED EMPLOYEES IN THE DEPARTMENT.

REVISOR'S NOTE: This section is new language derived without substantive change from former Art. 101, § 35C(c) and, as it related to auxiliary police officers, (b) and, as they related to a member of a volunteer police department, § 21(c)(5)(i) and the second sentence of (b)(4).

In subsection (b)(2) of this section, the reference to Cecil County is added, although Ch. 523, Acts of 1989, struck the reference to Cecil County from former Art. 101, § 21(c)(5)(i). By its title, Ch. 523 was limited in effect to members of volunteer fire companies and rescue squads. See Md. Constitution, Art. III, § 29.

As to the substitution of the defined term "covered employee" for the former reference to "[w]orkmen for wages" and "[e]mployed", see the revisor's note to § 9-101(f) of this title.

9-221. PRISONER.

(A) IN GENERAL.

A PRISONER IS A COVERED EMPLOYEE WHILE THE PRISONER IS WORKING FOR A BOARD OF COUNTY COMMISSIONERS, A COUNTY COUNCIL, OR A COUNTY ROADS BOARD IF:

(1) THE COUNTY PAYS THE PRISONER A WAGE OR STIPULATED SUM; AND

(2) THE PRISONER SUSTAINS PERMANENT PARTIAL OR PERMANENT TOTAL DISABILITY OR DIES, AS A RESULT OF AN ACCIDENTAL INJURY.
