9-609. RECEIPT OF COMPENSATION OR DAMAGES UNDER LAW OF ANOTHER STATE.

IF A COVERED EMPLOYEE OR THE DEPENDENTS OF A COVERED EMPLOYEE RECEIVE COMPENSATION OR DAMAGES UNDER THE LAW OF ANOTHER STATE, THIS TITLE MAY NOT BE CONSTRUED TO ALLOW A TOTAL COMPENSATION FOR THE SAME ACCIDENTAL INJURY OR OCCUPATIONAL DISEASE THAT IS GREATER THAN THE TOTAL COMPENSATION PROVIDED UNDER THIS TITLE.

9-610. OFFSET AGAINST OTHER BENEFITS.

- (A) COVERED EMPLOYEE OF GOVERNMENTAL UNIT OR QUASI-PUBLIC CORPORATION.
- (1) IF A STATUTE, CHARTER, ORDINANCE, RESOLUTION, REGULATION, OR POLICY, REGARDLESS OF WHETHER PART OF A PENSION SYSTEM, PROVIDES A BENEFIT TO A COVERED EMPLOYEE OF A GOVERNMENTAL UNIT OR A QUASI-PUBLIC CORPORATION THAT IS SUBJECT TO THIS TITLE UNDER § 9-201(2) OF THIS TITLE OR, IN CASE OF DEATH, TO THE DEPENDENTS OF THE COVERED EMPLOYEE, PAYMENT OF THE BENEFIT BY THE EMPLOYER SATISFIES, TO THE EXTENT OF THE PAYMENT, THE LIABILITY OF THE EMPLOYER AND THE SUBSEQUENT INJURY FUND FOR PAYMENT OF BENEFITS UNDER THIS TITLE.
- (2) IF A BENEFIT PAID UNDER PARAGRAPH (1) OF THIS SUBSECTION IS LESS THAN THE BENEFITS PROVIDED UNDER THIS TITLE, THE EMPLOYER, THE SUBSEQUENT INJURY FUND, OR BOTH SHALL PROVIDE AN ADDITIONAL BENEFIT THAT EQUALS THE DIFFERENCE BETWEEN THE BENEFIT PAID UNDER PARAGRAPH (1) OF THIS SUBSECTION AND THE BENEFITS PROVIDED UNDER THIS TITLE.
