(L) THE BOARD OF TRUSTEES MAY REQUIRE ANY OFFICERS, BOARDS, OR COMMISSIONS OF THE STATE OR POLITICAL SUBDIVISION OF THE STATE TO FURNISH IT, UPON APPLICATION AND WITHOUT COST, CERTIFIED COPIES OF ANY RECORDS OR PAPERS IN THEIR OFFICIAL CUSTODY, AND TO REQUIRE THE ATTENDANCE OF WITNESSES AND THE PRODUCTION OF PAPERS, UNDER SUMMONS, SUBPOENA, OR OTHER PROCESS, BEFORE THE BOARD WHEN CONSIDERED NECESSARY FOR THE PROPER ADMINISTRATION AND ENFORCEMENT OF THIS ARTICLE OR OF THE REGULATIONS ADOPTED IN ACCORDANCE WITH THIS ARTICLE. FOR THIS PURPOSE THE BOARD, OR ANY MEMBER OF THE BOARD, MAY ADMINISTER OATHS TO THE WITNESSES.

- (M) (1) IN ADDITION TO HEARINGS REQUIRED UNDER THE PROVISIONS OF THE ADMINISTRATIVE PROCEDURE ACT, THE BOARD OF TRUSTEES MAY HOLD HEARINGS WHEN DEEMED NECESSARY IN THE PERFORMANCE OF ITS DUTY. THE HEARINGS SHALL BE GOVERNED BY RULES AND REGULATIONS OF THE BOARD AND THE BOARD SHALL NOT BE BOUND BY TECHNICAL RULES OF EVIDENCE.
- (2) IN THE EVENT ANY APPLICATION FOR DISABILITY RETIREMENT ON BEHALF OF A STATE POLICE OFFICER UNDER ARTICLE 88B, § 15(B)(16) OF THE CODE IS APPROVED BY THE BOARD OF TRUSTEES FOR MARYLAND STATE RETIREMENT AND PENSION SYSTEMS, THE BOARD OF TRUSTEES SHALL HOLD A HEARING UNLESS WAIVED IN WRITING BY THE OFFICER BEING RETIRED.
