

Thus, Section 2 of Ch. 767, Acts of 1989, as amended by Ch. 287, Acts of 1991, created temporary changes in the required budgetary estimates to be made by the Board of Trustees, and unless the General Assembly amends Section 2 of Ch. 767, Acts of 1989, as amended by Ch. 287, Acts of 1991, the required budgetary estimates revert to the requirements as of June 30, 1989.

These requirements that formerly appeared in Art. 73B, §§ 14(3), 89(3), 122(3), and 150(3), and Art. 88B, § 56(3) are consolidated into one provision in this section.

#### 1-305. STATE CONTRIBUTIONS FOR SYSTEMS OTHER THAN THE TEACHERS' SYSTEMS.

(A) ON OR BEFORE THE FIRST DAY OF DECEMBER NEXT PRECEDING EACH REGULAR MEETING OF THE GENERAL ASSEMBLY OF MARYLAND, THE BOARD OF TRUSTEES SHALL CERTIFY TO THE GOVERNOR THE RATES TO BE USED IN DETERMINING THE AMOUNTS WHICH WILL BECOME DUE AND PAYABLE DURING THE YEAR NEXT FOLLOWING TO EACH OF THE SEVERAL FUNDS OF THE SEVERAL SYSTEMS, OTHER THAN THE TEACHERS' RETIREMENT SYSTEM OR PENSION SYSTEM FOR TEACHERS. THE AGGREGATE AMOUNT FOR EACH SYSTEM THUS ASCERTAINED SHALL BE INCLUDED IN THE BUDGET BILL WHICH IS SUBMITTED TO THE GENERAL ASSEMBLY.

(B) THE COMPTROLLER SHALL COMPUTE FOR EVERY UNIT OF STATE GOVERNMENT THE AMOUNTS TO BE CHARGED TO THE APPROPRIATION OF THE UNIT AS THE EMPLOYER'S SHARE OF EMPLOYEE RETIREMENT COST THAT IS CHARGEABLE TO THE FUND OF THE UNIT. THE COMPTROLLER SHALL MAKE THE COMPUTATION USING THE TOTAL RATES OF CONTRIBUTIONS AS SET BY THE ACTUARY OF THE SEVERAL SYSTEMS IN ACCORDANCE WITH § 1-306 OF THIS SUBTITLE.

(C) AS PAYROLLS ARE PAID, THE COMPTROLLER SHALL DRAW A WARRANT OR WARRANTS ON THE STATE TREASURER, IN THE AMOUNTS CHARGED AGAINST THE BUDGETS OF THE VARIOUS STATE AGENCIES UNDER SUBSECTION (B) OF THIS SECTION, FOR THE EMPLOYERS' CONTRIBUTIONS TO THE APPROPRIATE SYSTEMS. ON THE RECEIPT OF THE WARRANT OF THE COMPTROLLER, THE STATE TREASURER SHALL IMMEDIATELY TRANSFER TO THE APPROPRIATE SYSTEM THE AMOUNTS DUE.
