

(5) THE SELECTION OF OPTIONS FOR SERVICE OR DISABILITY ALLOWANCES;

(6) THE ADJUSTMENT OF THE ALLOWANCE FOR INCREASES IN THE CONSUMER PRICE INDEX;

(7) THE DEATH BENEFIT;

(8) THE LEVEL OF CONTRIBUTIONS FROM MEMBERS; AND

(9) THE LENGTH OF SERVICE FOR MEMBERS TO VEST BENEFITS IN THE SYSTEM.

(C) A MEMBER WHO IS SUBJECT TO § 2-415, § 2-416, OR § 2-417 OF THIS TITLE WHO RECEIVES CREDITABLE SERVICE FROM JULY 1, 1984, IS SUBJECT ONLY TO THE PROVISIONS OF THE APPLICABLE SECTION FOR THE PROPORTION OF EARNABLE COMPENSATION THAT IS PAYABLE, THE COMPUTATION OF THE ALLOWANCE, AND THE ADJUSTMENT OF THE ALLOWANCE.

2-208. CONTINUATION OF MEMBERSHIP AFTER EXPIRATION OF TERM OF OFFICE.

ANY MEMBER OF THE RETIREMENT SYSTEM WHO IS CURRENTLY A MEMBER BY VIRTUE OF BEING AN ELECTED OR APPOINTED OFFICIAL SHALL HAVE THE RIGHT AT THE MEMBER'S OPTION TO CONTINUE MEMBERSHIP IN THE SYSTEM FOLLOWING THE END OF THE TERM OF OFFICE FOR WHICH THE MEMBER WAS LAST ELECTED OR APPOINTED. THE RIGHT SHALL BE CONTINGENT UPON THE PERSON MAKING ALL THE PAYMENTS WHICH WOULD HAVE BEEN MADE BY THE MEMBER AND BY THE MEMBER'S EMPLOYER HAD THE PERSON CONTINUED TO BE A MEMBER OF THE SYSTEM BY VIRTUE OF HOLDING THE ELECTIVE OR APPOINTED OFFICE.

2-209. CONTINUATION OF MEMBERSHIP OF FORMER OFFICIALS UPON PROPER PAYMENTS.

ANY FORMER MEMBER OF THE RETIREMENT SYSTEM WHO WAS FORMERLY A MEMBER BY VIRTUE OF BEING AN ELECTED OR APPOINTED OFFICIAL SHALL HAVE THE RIGHT TO CONTINUE MEMBERSHIP IN THE SYSTEM. THE RIGHT SHALL BE CONTINGENT UPON THE PERSON MAKING
