2-210. TERMINATION OF MEMBERSHIP.

MEMBERSHIP CEASES IF THE MEMBER:

- (1) IS ABSENT FROM SERVICE FOR MORE THAN 2 YEARS;
- (2) WITHDRAWS THE MEMBER'S ACCUMULATED CONTRIBUTIONS;
- (3) BECOMES A RETIREE; OR
- (4) DIES.

2-211. LIMITATION ON MEMBERSHIP.

NO OTHER PROVISION OF LAW IN ANY OTHER STATUTE WHICH PROVIDES WHOLLY OR PARTLY AT THE EXPENSE OF THE STATE OF MARYLAND FOR PENSIONS OR RETIREMENT BENEFITS FOR EMPLOYEES OF THE STATE, THEIR SURVIVING SPOUSES, OR OTHER DEPENDENTS, SHALL APPLY TO MEMBERS OR BENEFICIARIES OF THE RETIREMENT SYSTEM ESTABLISHED BY THIS TITLE, THEIR SURVIVING SPOUSES OR OTHER DEPENDENTS EXCEPT BENEFITS FROM SOCIAL SECURITY; BUT THIS SECTION DOES NOT APPLY TO ANY PERSON WITH RESPECT TO WHOSE PENSION OR RETIREMENT ALLOWANCE ESTABLISHED UNDER OTHER LAW THE STATE DOES NOT CONTRIBUTE, AND IT DOES NOT APPLY TO THE BENEFICIARIES OF SUCH A PERSON.

SUBTITLE 3. CREDITABLE SERVICE.

2-301. CREDITABLE SERVICE; GENERALLY.

(A) CREDITABLE SERVICE AT RETIREMENT ON WHICH THE ALLOWANCE OF A MEMBER IS BASED SHALL CONSIST OF:

- (1) MEMBERSHIP SERVICE; AND
- (2) OTHER CREDIT AS FOLLOWS:
