- (3) A PERIOD OF TIME A MEMBER HAS BEEN EMPLOYED AS A STAFF MEMBER FOR THE COMMISSION TO REVISE THE ANNOTATED CODE;
- (4) A PERIOD OF TIME A MEMBER HAS BEEN EMPLOYED BY THE DIVISION OF EMPLOYMENT SERVICE WHEN THE DIVISION OF EMPLOYMENT SERVICE WAS UNDER FEDERAL CONTROL;
- (5) A PERIOD OF TIME A MEMBER HAS BEEN EMPLOYED BY THE MARYLAND TUBERCULOSIS ASSOCIATION AND OPERATED ANY RADIOLOGIC EQUIPMENT UNDER THE SUPERVISION OF THE MARYLAND HEALTH DEPARTMENT OR ITS SUCCESSORS:
- (6) A PERIOD OF TIME A MEMBER HAS BEEN EMPLOYED BY THE STATE OR A PARTICIPATING MUNICIPAL CORPORATION ON A TEMPORARY OR EMERGENCY BASIS;
- (7) A PERIOD OF PRIOR MEMBERSHIP IN THE STATE POLICE RETIREMENT SYSTEM FOR WHICH THE FORMER MEMBER WAS NOT VESTED IN THE STATE POLICE RETIREMENT SYSTEM;
- (8) A PERIOD OF TIME DURING WHICH MEMBERSHIP HAS BEEN MANDATORY BUT FOR WHICH EMPLOYEE CONTRIBUTIONS WERE NOT MADE; AND
- (9) A PERIOD OF EMPLOYER-APPROVED LEAVE OF ABSENCE NOT EXCEEDING 2 YEARS THAT HAS QUALIFIED AS CREDITABLE SERVICE UNDER REGULATIONS ADOPTED BY THE BOARD OF TRUSTEES.
- (B) A MEMBER WHO IS ELIGIBLE TO PURCHASE CREDIT UNDER SUBSECTION (A) OF THIS SECTION MAY PURCHASE THE CREDIT BY MAKING A SINGLE PAYMENT CONSISTING OF THE CONTRIBUTIONS THE MEMBER WOULD HAVE MADE UNDER THIS SYSTEM DURING THE PERIOD BEING PURCHASED, WITH REGULAR INTEREST TO DATE OF PAYMENT.
