- (4) FOR RETIREMENT FOR ACCIDENTAL DISABILITY, THE ALLOWANCE IS COMPUTED:
- (I) FOR CREDITABLE SERVICE BEFORE JULY 1, 1984, AS PROVIDED BY \S 2–404(B) OF THIS SUBTITLE; AND
- (II) FOR CREDITABLE SERVICE FROM JULY 1, 1984, AS PROVIDED BY § 4–404(B) OF THIS ARTICLE.
- (D) ADJUSTMENTS. A MEMBER WHO RETIRES FROM JULY 1, 1984 SHALL HAVE THE ALLOWANCE ADJUSTED:
- (1) FOR CREDITABLE SERVICE BEFORE JULY 1, 1984, AS PROVIDED BY § 2–413 OF THIS SUBTITLE; AND
- (2) FOR CREDITABLE SERVICE FROM JULY 1, 1984, AS PROVIDED BY § 4-413 OF THIS ARTICLE.
- (E) MEMBERS' CONTRIBUTIONS. FOR CREDITABLE SERVICE RECEIVED FROM JULY 1, 1984, THE PROPORTION OF THE EARNABLE COMPENSATION THAT IS PAYABLE BY A MEMBER IS THAT PROVIDED BY § 4–202(A) OF THIS ARTICLE.
- (F) TRANSFER TO PENSION SYSTEM FOR EMPLOYEES. A MEMBER WHO IS SUBJECT TO THIS SECTION MAY TRANSFER TO THE PENSION SYSTEM FOR EMPLOYEES OF THE STATE OF MARYLAND, AS PROVIDED BY § 4–201 OF THIS ARTICLE WITH ACCUMULATED CONTRIBUTIONS RETURNED TO THE MEMBER AS OF THE DATE OF TRANSFER PURSUANT TO § 2–204 OR § 3–204 OF THIS ARTICLE WITH THE AVERAGE RATE OF INTEREST FOR THE 5 YEARS PRECEDING THE YEAR OF TRANSFER COMPOUNDED ANNUALLY. THE RATE OF INTEREST FOR ANY ONE YEAR SHALL BE COMPUTED AS THE SUM OF THE INVESTMENT INCOME AND THE REALIZED GAINS AND LOSSES DIVIDED BY THE BOOK VALUE OF THE TOTAL INVESTMENTS.
- (G) APPORTIONMENT OF UNUSED SICK LEAVE. A MEMBER WHO IS SUBJECT TO THIS SECTION AND WHO AT THE TIME OF RETIREMENT IS ENTITLED TO CREDIT FOR UNUSED SICK LEAVE UNDER § 2–302 OF THIS TITLE SHALL HAVE THE TOTAL AMOUNT OF UNUSED SICK LEAVE CREDIT APPORTIONED IN THE SAME RATIO THAT THE MEMBER'S CREDITABLE SERVICE IS APPORTIONED FOR CALCULATION OF THE ALLOWANCE UNDER SUBSECTION (C) OF THIS SECTION.
- (H) CREDITABLE SERVICE. FOR PURPOSES OF COMPUTING A MEMBER'S ALLOWANCE:
- (1) CREDITABLE SERVICE RECEIVED BY A MEMBER, OTHER THAN SINCE THE INDIVIDUAL LAST BECAME A MEMBER, SHALL BE TREATED AS CREDITABLE SERVICE AS OF THE DATE THE SERVICE WAS RENDERED. THIS PROVISION DOES NOT APPLY TO SERVICE CREDIT RECEIVED PURSUANT TO ARTICLE 65, SECTION 88 OF THE CODE; AND
