- (6) A RETIREE RESTORED TO ACTIVE SERVICE AT A SALARY LESS THAN THE AVERAGE FINAL COMPENSATION UPON THE BASIS OF WHICH THE RETIREE WAS RETIRED MAY NOT BECOME A MEMBER OF THE RETIREMENT SYSTEM UNTIL THE RETIREE'S SALARY IS AT LEAST EQUAL TO THAT AVERAGE FINAL COMPENSATION.
- (G) IF A DISABILITY RETIREE UNDER AGE 60 IS RESTORED TO ACTIVE SERVICE AT A COMPENSATION OF NOT LESS THAN THE RETIREE'S AVERAGE FINAL COMPENSATION:
 - (1) THE RETIREE'S RETIREMENT ALLOWANCE SHALL CEASE;
- (2) THE RETIREE SHALL AGAIN BECOME A MEMBER OF THE RETIREMENT SYSTEM;
- (3) THE RETIREE SHALL CONTRIBUTE THEREAFTER AT THE SAME RATE THE RETIREE PAID PRIOR TO DISABILITY;
- (4) PREVIOUS CREDITABLE SERVICE SHALL BE RESTORED TO FULL FORCE AND EFFECT; AND
- (5) ON THE RETIREE'S SUBSEQUENT RETIREMENT, THE RETIREE SHALL BE CREDITED WITH ALL THE RETIREE'S SERVICE AS A MEMBER CREDITABLE TO THE MEMBER AT THE TIME OF RETIREMENT.
- (H) A PERSON WHO RETIRES ON AND AFTER JULY 1, 1982 AND IS RECEIVING DISABILITY BENEFITS SHALL PROVIDE MEDICAL AND EARNINGS INFORMATION ON AN ANNUAL BASIS AS THE BOARD OF TRUSTEES MAY REQUEST. IF THE PERSON REFUSES TO SUBMIT THE INFORMATION REQUESTED BY THE BOARD, THE PERSON'S RETIREMENT ALLOWANCE SHALL BE SUSPENDED FOR THE PERIOD OF REFUSAL.

3-405. EFFECT OF WORKERS' COMPENSATION BENEFITS.

ANY PENSION ALLOWANCE SHALL BE REDUCED BY THE AMOUNT OF ANY WORKERS' COMPENSATION BENEFITS PAID OR PAYABLE AFTER THE EFFECTIVE DATE OF RETIREMENT ON ACCOUNT OF AN ACCIDENTAL PERSONAL INJURY OR OCCUPATIONAL DISEASE ARISING OUT OF AND IN THE COURSE OF THE RETIREE'S EMPLOYMENT BY THE STATE IF THE WORKERS' COMPENSATION BENEFITS ARE PAID OR PAYABLE FOR A PERIOD DURING WHICH A PENSION ALLOWANCE IS PAID OR PAYABLE. THIS PROVISION IS APPLICABLE TO BOTH THE RETIREE AND ANY BENEFICIARY DESIGNATED UNDER ANY OPTION PROVIDED UNDER THIS TITLE. HOWEVER, THE PENSION ALLOWANCE TO BE REDUCED SHALL BE
