10-203. LEGISLATIVE POLICY.

THE GENERAL ADMINISTRATION, FUNDING, AND RESPONSIBILITY FOR THE PROPER OPERATION OF THIS PENSION SYSTEM IS VESTED IN THE BOARD OF TRUSTEES FOR THE MARYLAND STATE RETIREMENT AND PENSION SYSTEMS. EXCEPT AS OTHERWISE PROVIDED IN THIS SUBTITLE, THE PROPER OPERATION OF THIS PENSION SYSTEM SHALL BE THAT AS PROVIDED FOR THE OPERATION OF THE PENSION SYSTEM FOR EMPLOYEES OF THE STATE OF MARYLAND.

(A) ON OR AFTER JULY 1, 1989, IF A MUNICIPAL CORPORATION ELECTS TO PARTICIPATE IN THIS PENSION SYSTEM IN ACCORDANCE WITH \$ 10–224 OF THIS SUBTITLE, ANY PERSON WHO BECOMES A MUNICIPAL CORPORATION LAW ENFORCEMENT OFFICER OR FIRE FIGHTER OF THE MUNICIPAL CORPORATION AFTER THE MUNICIPAL CORPORATION BEGINS TO PARTICIPATE IN THIS SYSTEM SHALL BECOME A MEMBER OF THIS PENSION SYSTEM AS A CONDITION OF EMPLOYMENT.
