- (xiv) An agency on aging, as designated by the legislative body; [and]
- (xv) The University of Maryland Medical System Corporation as defined in § 13-1B-01(n) of the Education Article, but only for:
- 1. Medical System University personnel who were employees of the University of Maryland on June 30, 1988, who were members of the Employees' Retirement System or the Pension System for Employees of the State of Maryland, and who became Medical System Corporation employees on or before July 1, 1988; and
- 2. Medical System University personnel who were employees of the University of Maryland on June 30, 1990, who were members of the Employees' Retirement System or the Pension System for Employees of the State of Maryland, and who voluntarily became Medical System Corporation employees on or before July 1, 1991; AND
- (XVI) THE UNIVERSITY OF MARYLAND MEDICAL SYSTEM CORPORATION AS DEFINED IN § 13–1C–01(B) OF THE EDUCATION ARTICLE, BUT ONLY FOR MONTEBELLO UNIVERSITY EMPLOYEES AS DEFINED IN § 13–1C–01(G) OF THE EDUCATION ARTICLE:
- 1. WHO WERE EMPLOYEES OF THE UNIVERSITY OF MARYLAND SYSTEM ON JUNE 30, 1992;
- 2. WHO WERE MEMBERS OF THE EMPLOYEES' RETIREMENT SYSTEM OF THE STATE OF MARYLAND OR THE PENSION SYSTEM FOR THE EMPLOYEES OF THE STATE OF MARYLAND; AND
- 3. WHO BECAME EMPLOYEES OF THE UNIVERSITY OF MARYLAND MEDICAL SYSTEM CORPORATION IN ACCORDANCE WITH § 13–1C–04 OF THE EDUCATION ARTICLE.

- (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.
- (B) "MEDICAL SYSTEM CORPORATION" MEANS THE UNIVERSITY OF MARYLAND MEDICAL SYSTEM CORPORATION OR, AT THE MEDICAL SYSTEM CORPORATION'S OPTION, A SUBSIDIARY OR AFFILIATE OF THE MEDICAL SYSTEM CORPORATION.
  - (C) "MONTEBELLO" MEANS THE MONTEBELLO CENTER.
- (D) "MONTEBELLO ASSETS" MEANS ALL ASSETS ALLOCATED TO MONTEBELLO AS SHOWN ON THE FINANCIAL STATEMENTS OF MONTEBELLO AT THE TRANSFER DATE AND AS MORE PARTICULARLY OR
