- (A) (1) EXCEPT IN MONTGOMERY AND ST. MARY'S COUNTIES <u>AND</u> EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION FOR <u>BALTIMORE COUNTY</u>, THE CLERK OF EACH CIRCUIT COURT SHALL:
- (1) (I) COLLECT, IN ADVANCE, A \$20 \$10 FEE FOR DOCKETING THE APPEARANCE OF COUNSEL WHEN BRINGING OR DEFENDING A CIVIL ACTION IN THE COURT;
- (2) (II) CHARGE AS COSTS A \$20 \$10 FEE FOR DOCKETING THE APPEARANCE OF COUNSEL WHEN PROSECUTING OR DEFENDING A CRIMINAL ACTION IN THE COURT; AND
- (3) (III) COLLECT, IN ADVANCE, A \$20 \$10 FEE FOR DOCKETING THE APPEARANCE OF COUNSEL WHEN BRINGING OR DEFENDING A CASE IN THE COURT OF APPEALS.
- (2) IN THE CIRCUIT COURT FOR BALTIMORE COUNTY, THE CLERK OF THE CIRCUIT COURT IS ENTITLED TO DEMAND AND RECEIVE THE FOLLOWING FEES:
- (1) FOR BRINGING, PROSECUTING, OR DEFENDING ANY ACTION AT LAW IN A COURT OF ORIGINAL JURISDICTION—\$10;
- (II) FOR PROSECUTING OR DEFENDING ANY ACTION, INCLUDING THE COLLECTION OF MONEY DUE ON MORTGAGE, IN A COURT OF EQUITY \$20;
- (III) FOR PROSECUTING OR DEFENDING A CASE IN THE COURT OF APPEALS \$20;
- (IV) FOR PROSECUTING OR DEFENDING A CRIMINAL CASE IF THE PUNISHMENT FOR THE OFFENSE CHARGED IS DEATH OR CONFINEMENT IN THE PENITENTIARY—\$20; AND
 - (V) IN ALL OTHER CRIMINAL CASES \$10.
- (2) THE CLERK OF THE CIRCUIT COURT FOR BALTIMORE COUNTY
 SHALL:
- (I) <u>COLLECT, IN ADVANCE, THE FOLLOWING FEE FOR</u>

 <u>DOCKETING THE APPEARANCE OF COUNSEL WHEN BRINGING OR</u>

 <u>DEFENDING A CIVIL ACTION:</u>
- <u>1. A \$20 FEE FOR AN ACTION, INCLUDING THE</u> COLLECTION OF MONEY DUE ON MORTGAGE, IN A COURT OF EQUITY; AND
- <u>2. A \$10 FEE FOR AN ACTION AT LAW IN A COURT OF ORIGINAL JURISDICTION;</u>
- (II) CHARGE AS COSTS THE FOLLOWING FEE FOR DOCKETING THE APPEARANCE OF COUNSEL WHEN BRINGING OR DEFENDING A CRIMINAL ACTION:
