

[(h)] (E) [In Baltimore County, the] THE Clerk of the Circuit Court for [the county] BALTIMORE COUNTY shall transmit to the [county] COUNTY all appearance fees collected by [him] THE CLERK under [the provisions of subsection (a) of] this section to be used for the general purposes of the court library of the [county] COUNTY. These purposes include the necessary expenses for books and library equipment[,] and the services of the librarian.

[(i)] ~~(U)~~ (V) [In Wicomico County the] THE Clerk of the Circuit Court FOR WICOMICO COUNTY shall deposit all appearance fees collected BY THE CLERK under [subsection (a)] THIS SECTION into a special account known as "bar library account." The account shall be used for purchasing and maintaining legal publications recommended by the Wicomico County Bar Association and approved by the [resident] COUNTY ADMINISTRATIVE judge for Wicomico County. The account shall also be used to pay the salary of a librarian if a librarian is considered necessary by the Wicomico County Bar Association.

[(j)] ~~(R)~~ (S) [In Somerset County the] THE Clerk of the Circuit Court FOR SOMERSET COUNTY shall deposit monthly all appearance fees collected BY THE CLERK under [subsection (a)] THIS SECTION into a special account to be known as "the court and bar library account." The account shall be for the general use of the court library and for the maintenance and improvement of the court's facilities and equipment, subject to the approval of the resident circuit court judge.

[(k)] ~~(V)~~ (W) [In Worcester County the] THE Clerk of the Circuit Court FOR WORCESTER COUNTY shall deposit monthly all appearance fees collected BY THE CLERK under [subsection (a) of] this section into a special account to be known as the "Court and Bar Library Account". The account shall be for the general use of the court library and for the maintenance and improvement of the court's facilities and equipment, and together with other funds in the account, shall be disbursed upon the approval of the County Administrative Judge.

[(l)] (G) (1) [In Caroline County, the] THE Clerk of the Circuit Court FOR CAROLINE COUNTY shall deposit monthly all appearance fees collected BY THE CLERK under [subsection (a) of] this section into a special account to be known as the law library fund.

(2) The fund shall be used only for the law library of Caroline County upon recommendation of the Caroline County Bar Association.

[(m)] (I) [In Cecil County, the] THE Clerk of the Circuit Court FOR CECIL COUNTY shall retain all appearance fees collected BY THE CLERK under [subsection (a) of] this section for the general use of the court library of the [county] COUNTY, including expenses for books and library equipment.

[(n)] ~~(F)~~ (U) (1) [In Washington County, the] THE Clerk of the Circuit Court FOR WASHINGTON COUNTY shall deposit monthly all appearance fees collected under [subsection (a) of] this section into a special account to be known as the Washington County Court Library Fund.
