

~~(P)~~ (Q) (1) THE CLERK OF THE CIRCUIT COURT FOR PRINCE GEORGE'S COUNTY SHALL TRANSMIT TO THE COUNTY ALL APPEARANCE FEES COLLECTED BY THE CLERK UNDER THIS SECTION TO BE USED FOR THE GENERAL PURPOSES OF THE COURT LIBRARY AND ASSIGNMENT OFFICE AND FOR THE MAINTENANCE AND IMPROVEMENT OF THE COURT'S FACILITIES, EQUIPMENT, AND PROGRAMS. THESE PURPOSES INCLUDE, BUT ARE NOT LIMITED TO, THE NECESSARY EXPENSES FOR BOOKS, LEGAL PUBLICATIONS, LIBRARY EQUIPMENT, AND THE SERVICES OF THE LIBRARY AND OTHER PERSONNEL.

(2) EXPENDITURES FOR THE LIBRARY ARE NOT LIMITED TO THIS FUND IF THE SAME SHOULD BE DEEMED INSUFFICIENT BY THE COUNTY ADMINISTRATIVE JUDGE.

[(s) In Montgomery County, the Clerk of the Circuit Court for Montgomery County may not collect any appearance fees.]

[(t)] (J) (1) [In Charles County the] THE Clerk of the Circuit Court FOR CHARLES COUNTY shall deposit monthly all appearance fees collected BY THE CLERK under [subsection (a) of] this section into a special account to be known as the Charles County Law Library Fund.

(2) The Fund shall be used only for the general use of the Circuit Court Law Library for the acquisition of books and other publications, library equipment, and for other necessary expenses, as determined by the County Administrative Judge.

[(u)] ~~(L)~~ (M) (1) [In Garrett County, the] THE Clerk of the Circuit Court FOR GARRETT COUNTY shall deposit monthly all appearance fees collected BY THE CLERK under [subsection (a) of] this section into a special account to be known as the Garrett County Law Library Fund.

(2) The Fund shall be used only for the acquisition of books and other publications, library equipment, and for other necessary expenses, as determined by the County Administrative Judge.

[(v) In St. Mary's County, the Clerk of the Circuit Court for St. Mary's County may not collect any appearance fees.]

(w) In Anne Arundel County, all appearance fees provided for under subsection (a) of this section shall be set at \$10.]

[(x)] (F) (1) [In Calvert County, the] THE Clerk of the Circuit Court FOR CALVERT COUNTY shall deposit monthly all appearance fees collected BY THE CLERK under [subsection (a) of] this section into a special account to be known as the Calvert County Law Library Fund.

(2) The Fund shall be used only for the acquisition of books and other publications, library equipment, and other necessary expenses, as determined by the County Administrative Judge.
