

(II) [to] IN a position of equal [responsibility] RESPONSIBILITIES, qualifications, and RATE OF pay[, provided:].

(2) IF, BECAUSE OF A DISABILITY SUSTAINED DURING MILITARY SERVICE, A RETURNING VETERAN IS NOT QUALIFIED TO PERFORM THE DUTIES OF THE POSITION THAT THE VETERAN PREVIOUSLY HELD, THE RETURNING VETERAN SHALL BE ~~REEMPLOYED~~ REINSTATED IN A POSITION THAT:

(I) HAS DUTIES THAT THE RETURNING VETERAN IS QUALIFIED TO PERFORM; AND

(II) PROVIDES THE RATE OF PAY, SENIORITY, AND STATUS THAT ARE THE SAME OR AS SIMILAR AS THE CIRCUMSTANCES OF THE CASE ALLOW TO THOSE OF THE POSITION PREVIOUSLY HELD BY THE RETURNING VETERAN.

(3) PARAGRAPHS (1) AND (2) OF THIS SUBSECTION SHALL BE IMPLEMENTED UNLESS THE CIRCUMSTANCES IN THE STATE GOVERNMENT HAVE CHANGED TO THE EXTENT THAT IMPLEMENTATION IS IMPOSSIBLE OR UNREASONABLE.

(D) (1) (I) [He makes application within ninety days from the date of his separation from the armed forces in case he has involuntarily entered, or] A RETURNING VETERAN WHO WAS INDUCTED SHALL SUBMIT AN APPLICATION FOR ~~REEMPLOYMENT~~ REINSTATEMENT WITHIN 90 DAYS AFTER THE RETURNING VETERAN IS DISCHARGED FROM MILITARY SERVICE;

(II) [within ninety days after the termination of his first period of enlistment in case he has voluntarily entered, for reinstatement as a State employee] THE RETURNING VETERAN WHO ENLISTED FOR THE PERIOD DESCRIBED IN 38 U.S.C. § 2024(A) SHALL SUBMIT AN APPLICATION FOR ~~REEMPLOYMENT~~ REINSTATEMENT WITHIN 90 DAYS AFTER THAT ENLISTMENT PERIOD ENDS; [and] OR

(III) [(2) He makes application for reinstatement within ninety days from the date of separation from such service] A RETURNING VETERAN, WHO WAS CALLED TO ACTIVE DUTY FOR THE PERIOD DESCRIBED IN 38 U.S.C. § 2024(B) SHALL SUBMIT AN APPLICATION FOR ~~REEMPLOYMENT~~ REINSTATEMENT WITHIN 90 DAYS AFTER THE RETURNING VETERAN IS RELIEVED FROM THAT DUTY; or

(2) [within ninety days after discharge] A RETURNING VETERAN WHO WAS HOSPITALIZED ON THE DATE OF DISCHARGE, END OF ENLISTMENT, OR RELEASE FROM ACTIVE DUTY SHALL SUBMIT AN APPLICATION FOR ~~REEMPLOYMENT~~ REINSTATEMENT WITHIN 90 DAYS AFTER THE
