SYSTEM FOR EMPLOYEES OF THE STATE OF MARYLAND AND ALL OTHER SYSTEMS EACH OF THE SYSTEMS OR GROUPS OF SYSTEMS SPECIFIED IN SUBPARAGRAPH (II) OF THIS PARAGRAPH:

- (i) $\underline{1}$. The percentage participation of [any particular] THE system OR SYSTEMS;
- (ii) 2. The percentage of income, gains, and losses applicable to [each] THE system OR SYSTEMS; and
- (iii) 3. The total contributions and disbursements applicable to [each] THE system OR SYSTEMS.
- (II) THE BOARD OF TRUSTEES SHALL MAINTAIN THE RECORDS REQUIRED UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH FOR EACH OF THE FOLLOWING SYSTEMS OR GROUPS OF SYSTEMS:
- 1. THE TEACHERS' RETIREMENT SYSTEM OF THE STATE OF MARYLAND AND THE PENSION SYSTEM FOR TEACHERS OF THE STATE OF MARYLAND;
- 2. THE STATE POLICE RETIREMENT SYSTEM OF THE STATE OF MARYLAND;
- 3. A. THE EMPLOYEES' RETIREMENT SYSTEM OF THE STATE OF MARYLAND;
- <u>B.</u> <u>THE PENSION SYSTEM FOR EMPLOYEES OF THE STATE OF MARYLAND;</u>
- <u>C.</u> <u>THE CORRECTIONAL OFFICERS' RETIREMENT</u> <u>SYSTEM OF THE STATE OF MARYLAND; AND</u>
- <u>D.</u> <u>THE LEGISLATIVE RETIREMENT PLAN OF THE STATE</u> <u>OF MARYLAND;</u>
- 4. <u>THE NATURAL RESOURCES LAW ENFORCEMENT</u> OFFICERS' PENSION SYSTEM;
- <u>5.</u> <u>THE JUDGES' RETIREMENT SYSTEM OF THE STATE</u> <u>OF MARYLAND; AND</u>
- 6. THE MUNICIPAL CORPORATIONS LAW ENFORCEMENT OFFICERS' AND FIRE FIGHTERS' PENSION SYSTEM.
- SECTION 2. 3. AND BE IT FURTHER ENACTED, That <u>Section 1 of</u> this Act shall take effect July June 1, 1992.
- SECTION 4. AND BE IT FURTHER ENACTED, That Section 2 of this Act shall take effect July 1, 1992.
