2. In Worcester County, the license fee is \$100 for a resident of Worcester County who sells only ice cream.

IF THE COUNTY COMMISSIONERS OF ST. MARY'S COUNTY SET A LICENSE FEE FOR A LICENSE ISSUED UNDER § 17–907 OF THIS SUBTITLE, THE COUNTY COMMISSIONERS SHALL NOTIFY THE COMPTROLLER OF THE TREASURY BY DECEMBER 31 OF THE YEAR BEFORE THE YEAR THE LICENSE FEE TAKES EFFECT.

Article 19 - St. Mary's County

61-1.

- A. (1) [No] A huckster, hawker or peddler [shall] MAY NOT sell or offer for sale any fruits or vegetables in St. Mary's County [until he shall have first taken out] WITHOUT a license [for that purpose in accordance with the provisions of this section; provided, however, that this].
- (2) THIS section [shall] DOES not apply to [the] farmers or growers selling their own fruits or vegetables.
- B. (1) [For every such license,] AN APPLICANT FOR A LICENSE SHALL PAY AN ANNUAL LICENSE FEE SET BY THE COUNTY COMMISSIONERS, BY RESOLUTION, TO the Clerk of the Circuit Court of St. Mary's County [shall be paid one hundred dollars (\$100) per annum].
- (2) The CLERK OF THE COURT SHALL PAY THE receipts from [said] THE ISSUANCE OF THE licenses [shall be paid] to the County Treasurer for the use of [said] THE county.
- C. Any person violating the provisions of this section [shall, upon conviction, be fined not less than twenty-five dollars (\$25.) nor more than one hundred dollars (\$100.), to be recovered as other fines are recovered] ON CONVICTION IS SUBJECT TO A FINE NOT EXCEEDING \$1,000.

61-2.

- A. [It is unlawful for any] A person [to] MAY NOT conduct the business of or act as an itinerant or door-to-door peddler or salesman of goods, wares or merchandise, either by sample or otherwise, in St. Mary's County unless [he has secured and] THE PERSON holds a current license [as such,] issued [upon application] by the Sheriff of the county. As used [herein] IN THIS SECTION, "peddler or salesman" includes one who offers for sale or solicits subscriptions for magazines or other periodical publications.
- B. The Sheriff shall [prepare and have] MAKE available application forms for a peddler's and magazine seller's license, [containing] REQUIRING such [provisions and] information as, in the opinion of the Sheriff, may be necessary to keep [a proper and complete] AN APPROPRIATE listing of the persons in St. Mary's County who are engaged in these occupations [from time to time]. The license shall be issued [upon] ON
