(A) THERE IS A LEAD PAINT POISONING PREVENTION AND COMPENSATION FUND.

(B) THE PREVENTION FUND SHALL BE UNDER THE DIRECTION OF THE COMMISSION AND SHALL BE ADMINISTERED BY THE STAFF OF THE COMMISSION AS PROVIDED IN THE ANNUAL BUDGET OF THE STATE OR BY SUPPLEMENTAL APPROPRIATION.

(C) THE PREVENTION FUND SHALL BE A CONTINUING, NONLAPSING SPECIAL FUND, NOT SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE, CONSISTING OF:

(1) THE REGISTRATION FEES, ~~CERTIFICATION FEES, AND ADMINISTRATIVE COSTS FEES~~ TRANSFERRED INTO THE PREVENTION FUND UNDER § 6-808 OF THIS SUBTITLE; AND
