~~(A) (1) A PARENT OR GUARDIAN OF A CLAIMANT MAY FILE AN APPLICATION WITH THE FUND FOR AN IMMEDIATE GRANT FOR THE PURPOSE OF OBTAINING TEMPORARY EMERGENCY LEAD SAFE HOUSING AND OTHER EMERGENCY NEEDS AS DEFINED BY THE COMMISSION.~~

~~(2) THE COMMISSION, IN CONJUNCTION WITH THE DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT, SHALL COMPILE A REGISTRY OF LEAD SAFE HOUSING.~~

~~(B) THE APPLICATION FOR AN IMMEDIATE GRANT SHALL BE MADE UNDER OATH AND SUBJECT TO THE PENALTIES OF PERJURY.~~

~~(C) THE FUND SHALL AWARD THE GRANT WITHIN 30 DAYS AFTER THE DATE THE APPLICATION AND SUPPORTING EVIDENCE WERE FILED WITH THE FUND.~~
