SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

~~Article 27—Crimes and Punishments~~

402:

(A) ~~[It is unlawful for any] A person [to] MAY NOT knowingly, willfully, or falsely represent the age of any person to any licensed innkeeper, restaurant keeper, or other person engaged in the sale of alcoholic beverages for the purpose of inducing that person to illegally sell or furnish any alcoholic beverages to any person.~~

(B) (1) ~~THIS SUBSECTION APPLIES ONLY IN HARFORD COUNTY.~~

(2) ~~IN THIS SUBSECTION, "LICENSEE" MEANS THE OWNER OF A BUSINESS LICENSED TO SELL ALCOHOLIC BEVERAGES OR AN EMPLOYEE OF THE OWNER.~~

(3) (1) ~~EXCEPT AS PROVIDED IN SUBPARAGRAPH (III) OF THIS PARAGRAPH, A LICENSEE MAY BE PROSECUTED IF THE LICENSEE SERVES A PERSON AN ALCOHOLIC BEVERAGE AND KNOWS OR SHOULD HAVE KNOWN THAT THE PERSON WHO WAS SERVED HAS SHOWN THE LICENSEE A DRIVER'S LICENSE ISSUED BY THIS STATE BUT THAT WAS OBTAINED BY THE PERSON BY FALSIFIED INFORMATION OR DOCUMENTATION.~~

(II) ~~A LICENSEE SHALL ASK TO SEE ADDITIONAL IDENTIFICATION IF THE DRIVER'S LICENSE SHOWN TO THE LICENSEE BEARS A MARK, SUCH AS D 2, INDICATING THAT THE LICENSE IS A DUPLICATE.~~

(III) ~~A LICENSEE MAY NOT BE PROSECUTED IF A PERSON:~~
