[only if his state] enters into and maintains reciprocal agreements with the Department, approved by the [Attorney General] SECRETARY, which [extends a similar fishing privilege] ALLOW A PERSON POSSESSING A VALID MARYLAND ANGLER'S LICENSE ISSUED IN THAT PERSON'S NAME TO FISH from the Virginia or West Virginia banks of the Potomac River [to any Maryland resident who has a valid Maryland angler's license] without [requiring] ACQUIRING a Virginia or West Virginia fishing license.

- (b) [Any resident of Pennsylvania who possesses a fishing license valid in that state] A PERSON POSSESSING A VALID PENNSYLVANIA FISHING LICENSE ISSUED IN THAT PERSON'S NAME may fish [only] in the waters of the Conowingo and Youghiogheny Reservoirs without obtaining a Maryland angler's license. [Reciprocal fishing rights are limited to these reservoirs and do not extend to their tributaries.] This subsection is effective only if Pennsylvania first enters into and maintains a reciprocal agreement with the Department, approved by the [Attorney General] SECRETARY, which [extends a similar fishing privilege] ALLOWS A PERSON POSSESSING A VALID MARYLAND ANGLER'S LICENSE ISSUED IN THAT PERSON'S NAME TO FISH on the portion of the Conowingo and Youghiogheny Reservoirs lying within the boundaries of Pennsylvania [to any Maryland resident who has a valid State angler's license] without [requiring] ACQUIRING a Pennsylvania fishing license.
- (C) THE RECIPROCAL FISHING PRIVILEGES GRANTED TO PERSONS HOLDING VALID FISHING LICENSES FROM VIRGINIA, WEST VIRGINIA, AND PENNSYLVANIA BY THIS SECTION ARE VALID ONLY FOR THE MAINSTEM OF THE POTOMAC RIVER AND CONOWINGO AND YOUGHIOGHENY RESERVOIRS. A PERSON MAY NOT FISH IN ANY OTHER MARYLAND WATER, INCLUDING THE TRIBUTARIES OF THE POTOMAC RIVER AND CONOWINGO AND YOUGHIOGHENY RESERVOIRS, WITHOUT OBTAINING AN APPROPRIATE MARYLAND FISHING LICENSE.
- (D) IF A STATE FAILS TO MAINTAIN THE RECIPROCAL FISHING PRIVILEGES IN ACCORDANCE WITH AN APPROVED AGREEMENT, THE SECRETARY MAY REVOKE THE RECIPROCAL FISHING PRIVILEGES ACCORDED TO THOSE HOLDING LICENSES ISSUED BY THAT STATE BY PUBLISHING A NOTICE OF REVOCATION IN THE MARYLAND REGISTER AND NOTIFYING THE HEAD OF THE APPROPRIATE LICENSING AGENCY FOR THAT STATE.

## 4-611.

- (a) Any person engaged in a retail business who desires to sell angler's licenses as an agent under the Department's control and supervision shall apply to the Department on forms prepared and prescribed by the Department. The Department may furnish angler's licenses on consignment to any agent who provides a bond or other security deemed sufficient and adequate by the Department to insure payment for the licenses.
- [(b) The Department may not distribute to any agent less than the number of licenses of each type specified in this subsection:
  - (1) 10 resident
