~~(1) HAS FAILED TO CORRECT A DEFICIENCY IN ITS REGISTRATION MATERIAL WITHIN 30 DAYS AFTER NOTIFICATION OR A LONGER PERIOD THAT THE SECRETARY OF STATE SETS; OR~~
