~~(2) AN ORGANIZATION CONDUCTING ELDERLY SOLICITATION FOR THE FIRST TIME IN THE STATE SHALL SUBMIT A BOND IN AN AMOUNT THAT IS ONE AND ONE HALF OF THE EXPECTED RECEIPT OF MONEY OR OTHER VALUABLE CONSIDERATION RESULTING FROM THE SOLICITATION.~~
