~~(B) A DIRECTOR, OFFICER, PARTNER, OR TRUSTEE OF AN ORGANIZATION CONDUCTING ELDERLY SOLICITATION MAY NOT CAUSE THE ORGANIZATION TO VIOLATE THIS TITLE WILLFULLY.~~
