(IV) THAT PART OF PRINCE GEORGE'S COUNTY ELECTION DISTRICT 10, PRECINCT 1 THAT CONSISTS OF CENSUS TRACT 8002.04, BLOCKS 109 THROUGH 113, 119, 121 THROUGH 123, AND 128; AND

(Note: The census designations describe the area in Prince George's County precinct 10-1 that is north of Engleman Drive and Briarwood Drive.)

(V) THAT PART OF PRINCE GEORGE'S COUNTY ELECTION DISTRICT 10, PRECINCT 9 THAT CONSISTS OF THE FOLLOWING CENSUS TRACTS AND BLOCKS:
