

(VII) THAT PART OF MONTGOMERY COUNTY ELECTION DISTRICT 8, PRECINCT 2 THAT CONSISTS OF THE FOLLOWING CENSUS TRACTS AND BLOCKS:

1. CENSUS TRACT 7013.04, BLOCKS 101A, 210, 213 THROUGH 216, 301, 302, 304, 305, 308 THROUGH 311, 314, 315, 317, 318, AND 320 THROUGH 322; AND

2. CENSUS TRACT 7013.09, BLOCKS 111A, 111B, 112A THROUGH 112C, 113, 120, 122, AND 123.

(Note: The census designations describe the area in Montgomery County precinct 8-2 that is generally west of Georgia Avenue and north of Owens Road and James Creek.)

(15) LEGISLATIVE DISTRICT 15 CONSISTS OF:

(A) MONTGOMERY COUNTY ELECTION DISTRICTS 2, 3, 6, AND 11;

(B) MONTGOMERY COUNTY ELECTION DISTRICT 4, PRECINCTS 12, 17, 20, 23, AND 33;

(C) MONTGOMERY COUNTY ELECTION DISTRICT 10, PRECINCTS 1 THROUGH 6, 8, 9, AND 11 THROUGH 13; AND

(D) MONTGOMERY COUNTY ELECTION DISTRICT 12, PRECINCT 3.

(16) LEGISLATIVE DISTRICT 16 CONSISTS OF:

(A) MONTGOMERY COUNTY ELECTION DISTRICT 4, PRECINCTS 10, 13, 18, 28, 31, AND 32;

(B) MONTGOMERY COUNTY ELECTION DISTRICT 7, PRECINCTS 3, 4, 7 THROUGH 15, 17 THROUGH 20, 22 THROUGH 31, AND 33;

(C) MONTGOMERY COUNTY ELECTION DISTRICT 10, PRECINCTS 7 AND 10; AND

(D) THAT PART OF MONTGOMERY COUNTY ELECTION DISTRICT 13, PRECINCT 38 THAT CONSISTS OF CENSUS TRACT 7043, BLOCKS 206 THROUGH 213, 223, 224, 225, 301 THROUGH 314, 401 THROUGH 405, AND 407 THROUGH 414.

(Note: The census designations describe the area in Montgomery County precinct 13-38 that is generally south and east of Parkwood Drive and Parkwood Terrace.)

(17) LEGISLATIVE DISTRICT 17 CONSISTS OF:

(A) MONTGOMERY COUNTY ELECTION DISTRICT 4, PRECINCTS 1 THROUGH 9, 11, 14, 15, 16, 21, 22, 24, 25, 29, AND 30;
