

(D) PRINCE GEORGE'S COUNTY ELECTION DISTRICT 21, PRECINCTS 1, 2, 4, 5, 10, 14, AND 15;

(E) THAT PART OF PRINCE GEORGE'S COUNTY ELECTION DISTRICT 10, PRECINCT 1 THAT CONSISTS OF CENSUS TRACT 8002.04, BLOCKS 106 THROUGH 108 AND 124 THROUGH 127;

(Note: The census designations describe the area in Prince George's County precinct 10-1 that is south of Engleman Drive and Briarwood Drive.)

(F) THAT PART OF PRINCE GEORGE'S COUNTY ELECTION DISTRICT 10, PRECINCT 9 THAT CONSISTS OF CENSUS TRACT 8002.04, BLOCKS 129 AND 130;

(Note: The census designations describe the area in Prince George's County precinct 10-9 that is generally south of Old Stagecoach Road.)

(G) THAT PART OF PRINCE GEORGE'S COUNTY ELECTION DISTRICT 10, PRECINCT 10 THAT CONSISTS OF THE FOLLOWING CENSUS TRACTS AND BLOCKS:

(I) CENSUS TRACT 8002.06, BLOCKS 104, 106, 107, 110, AND 112;

(II) CENSUS TRACT 8002.08, BLOCKS 101B AND 136; AND

(III) CENSUS TRACT 8074.01, BLOCK 218;

(Note: The census designations describe the area in Prince George's County precinct 10-10 that is generally west of Beaverdam Creek Tributary, Pumpkin Hill Drive, and Laurel Bowie Road.)

(H) THAT PART OF ELECTION DISTRICT 17, PRECINCT 6 THAT CONSISTS OF THE FOLLOWING CENSUS TRACTS AND BLOCKS:

(I) CENSUS TRACT 8053, BLOCKS 101, 105, 201 THROUGH 203, 204C, 205B, 206A, AND 206B;

(II) CENSUS TRACT 8054, BLOCKS 101 THROUGH 123 AND 201 THROUGH 214; AND

(III) CENSUS TRACT 8055, BLOCKS 101B, 201B, 202 THROUGH 205, AND 211;
