

(4) [However, this section] THIS SUBSECTION is subject to the provisions of § 89(j) of this article regarding sales on New Year's Eve or New Year's Day regardless of the day of the week on which December 31 and January 1 fall.

(C) (1) A CLASS B RESTAURANT LICENSEE MAY SERVE ALCOHOLIC BEVERAGES FOR CONSUMPTION ON THE LICENSED PREMISES ON SUNDAY BETWEEN 1 P.M. AND 12 P.M. IF:

(I) THE ALCOHOLIC BEVERAGE IS SERVED AS A SUPPLEMENT TO THE MEAL; AND

~~(II) THE TOTAL ALCOHOLIC BEVERAGE BILL DOES NOT EXCEED THE TOTAL PRICE OF THE MEAL; AND~~

~~(HH) THE CUSTOMERS ARE SEATED AT A TABLE AND NOT AT THE BAR.~~

(2) A CLASS C LICENSEE MAY SERVE ALCOHOLIC BEVERAGES FOR CONSUMPTION ON THE LICENSED PREMISES ON SUNDAY BETWEEN 1 P.M. AND 12 P.M.

(3) IN ADDITION TO THE USUAL LICENSE FEE, THE HOLDER OF A LICENSE ISSUED PURSUANT TO THIS SUBSECTION SHALL PAY AN ADDITIONAL \$250 FOR THE PRIVILEGE OF SUNDAY SALES.

SECTION 2. AND BE IT FURTHER ENACTED, That before this Act becomes effective it shall first be submitted to a referendum of the legally qualified voters of Garrett County at the general election to be held in November of 1992. The cost of the special election, if any, shall be paid by the Board of County Commissioners. The Board of County Commissioners and the Board of Supervisors of Elections of Garrett County shall do those things necessary and proper to provide for and hold the referendum here required. There shall be printed on the ballots or ballot labels to be used at this election the title of this Act and underneath the title, on separate lines, a square or box to the right of and opposite the words; "For Sunday Sales" a corresponding square or box to the right of and opposite the words "Against Sunday Sales" so that each voter of the county may designate his or her decision for or against the provisions of this Act. If a majority of the votes cast in the election are "For Sunday Sales" the provisions of this Act shall become effective on the 30th day following the official canvass of votes for the referendum, but if a majority of the votes cast in the election are "Against Sunday Sales" the provisions of this Act shall be of no effect and null and void.

SECTION 3. AND BE IT FURTHER ENACTED, That subject to the provisions of Section 2 herein and for the sole purpose of providing for the referendum therein required this Act shall take effect on October 1, 1992.
