~~(II) MAY NOT HAVE A HOUSEHOLD MEMBER WHO IS SUBJECT TO THE AUTHORITY OF THE BOARD, AS AN EMPLOYEE.~~

~~(2) A MEMBER WHO NO LONGER RESIDES IN CAROLINE COUNTY MAY NOT CONTINUE AS A MEMBER OF THE BOARD.~~

~~(3) A MEMBER OF THE BOARD MAY NOT HOLD ANOTHER ELECTIVE OFFICE.~~

~~(C) (1) THE INCUMBENT MEMBERS OF THE CAROLINE COUNTY BOARD WHO HOLD OFFICE ON OCTOBER 1, 1992 SHALL HOLD OFFICE UNTIL THEIR SUCCESSORS ARE ELECTED AND QUALIFY.~~

~~(2) MEMBERS OF THE CAROLINE COUNTY BOARD SHALL BE ELECTED FROM CAROLINE COUNTY AT LARGE AS FOLLOWS:~~

~~(I) 3 MEMBERS OF THE COUNTY BOARD SHALL BE ELECTED IN THE NOVEMBER GENERAL ELECTION OF 1994 AND EVERY 4 YEARS AFTER TO REPLACE THE 3 INTERIM INCUMBENT MEMBERS OF THE BOARD WHOSE TERMS EXPIRE IN 1992, 1993, AND 1994; AND~~

~~(II) 2 MEMBERS OF THE COUNTY BOARD SHALL BE ELECTED IN THE NOVEMBER GENERAL ELECTION OF 1996 AND EVERY 4 YEARS AFTER TO REPLACE THE 2 INTERIM INCUMBENT MEMBERS OF THE BOARD WHOSE TERMS EXPIRE IN 1995 AND 1996.~~
