RESOLUTION OF THE COMMISSIONERS OF THE TOWN OF ABERDEEN TO AMEND SECTION 2 OF THE CHARTER OF THE TOWN OF ABERDEEN TO EXTEND THE CORPORATE BOUNDARIES AND TO DESIGNATE THE ZONING CLASSIFICATION OF THE LAND BEING ANNEXED.

CHARTER AMENDMENT NO. 45

A RESOLUTION OF THE COMMISSIONERS OF ABERDEEN ADOPTED PURSUANT TO THE AUTHORITY OF ARTICLE XIE OF THE CONSTITUTION OF MARYLAND AND OF ARTICLE 23A OF THE ANNOTATED CODE OF MARYLAND (1957 EDITION AND AMENDMENTS) TO REPEAL THE ENTIRE CHAPTER OF "THE COMMISSIONERS OF ABERDEEN", CODIFIED AS SECTIONS 1 THROUGH 76 (INCLUSIVE), TITLE "HARFORD COUNTY", SUBTITLE "ABERDEEN" OF THE CODE OF PUBLIC LOCAL LAWS OF HARFORD COUNTY (1965 EDITION AND AMENDMENTS), BEING ALSO ARTICLE 13 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND, AND TO ENACT, IN LIEU THEREOF, A NEW CHARTER UNDER THE NEW SUBTITLE OF "CITY OF ABERDEEN" TO BE CODIFIED AS NEW SECTIONS 1 THROUGH 92 (INCLUSIVE), CONVERTING THE COMMISSIONER FORM OF MUNICIPAL GOVERNMENT OF THE TOWN OF ABERDEEN TO THE MAYOR-CITY COUNCIL FORM OF MUNICIPAL GOVERNMENT UNDER THE NAME OF THE "CITY OF ABERDEEN", SPECIFYING THE MUNICIPAL CORPORATE POWERS, AND GENERALLY PROVIDING FOR THE TRANSITION FROM "THE COMMISSIONERS OF ABERDEEN" TO THE MAYOR-CITY COUNCIL MUNICIPAL FORM OF GOVERNMENT UNDER THE CORPORATE NAME OF THE "CITY OF ABERDEEN", ITS LAWFUL SUCCESSOR.
