

maintaining, possessing and/or operating any of the aforesaid machines without a license obtained from [said] THE Board, or of violating any regulation to be hereafter adopted by [said] THE Board for the issuance of [such] THE license and/or the maintenance and operation of any machine licensed hereunder shall be guilty of a misdemeanor and upon conviction thereof be fined not less than \$25 nor more than \$1,000.

Notwithstanding any other sections of [this article] THE BUSINESS REGULATION ARTICLE, in Cecil County any palm reader, fortune-teller, [or] soothsayer, [etc.,] OR SIMILAR PERSON shall apply to the Board of County Commissioners of Cecil County for a license to carry on [his] business. [Said] THE license shall be issued by the County Commissioners only upon proof that [said] THE person has been a resident, taxpayer, and property owner of Cecil County for at least [eighteen (18)] 18 months prior to the application for [said] THE license. The annual fee for [said] THE license shall be [ \$250.00] \$250 and the license shall be issued by the clerk of the Circuit Court of Cecil County and may be revoked by the Board for good cause.

Notwithstanding any other sections of [this article] THE BUSINESS REGULATION ARTICLE, in Charles County any palm reader, fortune-teller, [or] soothsayer, or similar person[,] shall apply to the Board of County Commissioners of Charles County for a license to carry on [such] business. The license shall be issued by the Board only upon proof that [said] THE person has been a resident, taxpayer, and property owner of Charles County for at least [eighteen (18)] 18 months prior to the application for THE license. The annual fee for the license shall be \$250, and the license shall be issued by the clerk of the Circuit Court and may be revoked by the Board for good cause.

134C.

(a) Notwithstanding any other sections of [this article] THE BUSINESS REGULATION ARTICLE, in Calvert County any palm reader, fortune-teller, [or] soothsayer, or similar person shall apply to the clerk of the Circuit Court for a license to carry on [such] business. The license shall be issued to cover only [three-month] 3-MONTH periods and the fee shall be [one thousand dollars (\$1,000.00)] \$1,000. Prior
