- (2) THE COUNTY EXECUTIVE OF MONTGOMERY COUNTY SHALL APPOINT [three (3) to be appointed] 3 MEMBERS, subject to the confirmation of the Montgomery County Council[, by the county executive of Montgomery County who may designate himself as one (1) of the three (3) members and three by the board of county commissioners of Prince George's County].
- (3) THE COUNTY EXECUTIVE OF PRINCE GEORGE'S COUNTY SHALL APPOINT 3 MEMBERS, SUBJECT TO THE CONFIRMATION OF THE PRINCE GEORGE'S COUNTY COUNCIL.
- (4) [and the secretary] THE SECRETARY of [transportation who] TRANSPORTATION shall be an ex-officio member OF THE COMMISSION and [who shall be] IS entitled to the same rights of membership as the appointed members. The [secretary] SECRETARY of [transportation] TRANSPORTATION may designate in writing an alternate [to represent him] REPRESENTATIVE, who shall have the same rights of membership as the [secretary] SECRETARY.
- (5) At least [one (1)] 1 commissioner from Prince George's County shall be appointed from among the members of the [board of county commissioners] PRINCE GEORGE'S COUNTY COUNCIL. The other commissioners may be selected from among the members of the [board of county commissioners of] Prince George's County COUNCIL or [may be selected] from qualified residents of Prince George's County [as the board of county commissioners sees fit].
- (6) THE COUNTY EXECUTIVES MAY DESIGNATE THEMSELVES AS 1 OF THE COMMISSIONERS FROM THEIR RESPECTIVE COUNTY.
- (7) Each commissioner [who shall be appointed by the county executive or from among the members of the board of county commissioners shall serve] SERVES at the pleasure of the APPOINTING county executive [and the board of county commissioners, respectively].
- (8) Commissioners [who are not appointed from the members of the board of county commissioners], OTHER THAN THE REQUIRED MEMBER FROM THE PRINCE GEORGE'S COUNTY COUNCIL, [shall be appointed for a period and] SERVE FOR A term of [three (3)] 3 years[; provided, however, that except for commissioners who have been appointed as of March 15, 1966, and who are not members of the respective governing bodies, commissioners shall be appointed for a three-year term and period by the respective governing bodies duly elected at the 1966 general election]. THE COMMISSIONER REQUIRED FROM THE PRINCE GEORGE'S COUNTY COUNCIL SERVES WHILE A MEMBER OF THE COUNTY COUNCIL, AND AT THE PLEASURE OF THE COUNTY EXECUTIVE AND COUNTY COUNCIL OF PRINCE GEORGE'S COUNTY.
- (9) Members of the commission shall serve until their successors have been appointed and qualified.
