- (3) THE NAMES OF ANY OTHER PARTIES TO THE ACQUISITION AGREEMENT;
- \qquad (4) The terms of the proposed acquisition, including the sale price;
 - (5) A COPY OF THE ACQUISITION AGREEMENT:
- (6) A FINANCIAL AND COMMUNITY IMPACT ANALYSIS REPORT FROM AN INDEPENDENT EXPERT OR CONSULTANT THAT ADDRESSES THE CRITERIA IN \S 6.5–301 OF THIS TITLE; AND
 - (7) ANY OTHER DOCUMENTS RELATED TO THE ACQUISITION.
- (C) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, ON REQUEST TO THE RECULATING ENTITY, AN APPLICATION AND RELATED DOCUMENTS SHALL BE AVAILABLE FOR PUBLIC INSPECTION AND COPYING.
- (2) THE RECULATING ENTITY MAY NOT BE REQUIRED TO DISCLOSE OR MAKE AVAILABLE FOR PUBLIC INSPECTION UNDER PARACRAPH (1) OF THIS SUBSECTION ANY INFORMATION THAT IS CONFIDENTIAL OR PROPRIETARY UNLESS DETERMINED BY THE RECULATING ENTITY TO BE IN THE PUBLIC INTEREST.
- (D) (1) IF THE TRANSFEROR IS A NONPROFIT HEALTH SERVICE PLAN, THE TRANSFEROR SHALL NOTIFY EACH SUBSCRIBER TO THE NONPROFIT—HEALTH SERVICE PLAN OF THE PROPOSED TRANSACTION BY FIRST CLASS MAIL WITHIN 10 DAYS OF THE SUBMISSION OF THE APPLICATION REQUIRED UNDER SUBSECTION (A) OF THIS SECTION.
- (2) IF THE TRANSFEROR IS A NONPROFIT HEALTH MAINTENANCE ORGANIZATION, THE TRANSFEROR SHALL NOTIFY EACH ENROLLEE MEMBER OR SUBSCRIBER OF THE NONPROFIT HEALTH MAINTENANCE ORGANIZATION OF THE PROPOSED TRANSACTION BY FIRST CLASS MAIL WITHIN 10 DAYS OF THE SUBMISSION OF THE APPLICATION REQUIRED UNDER SUBSECTION (A) OF THIS SECTION.
- (C) (1) ON REQUEST TO THE REGULATING ENTITY, AND SUBJECT TO PARAGRAPHS (2), (3), AND (4) OF THIS SUBSECTION, AN APPLICATION AND RELATED DOCUMENTS SHALL BE AVAILABLE FOR PUBLIC INSPECTION AND COPYING.
- (2) EXCEPT AS PROVIDED IN PARAGRAPHS (3) AND (4) OF THIS SUBSECTION OR OTHERWISE BY LAW, ALL INFORMATION AND DOCUMENTS THAT ARE FILED WITH THE REGULATING ENTITY IN COMPLIANCE WITH THE REQUIREMENTS OF THIS TITLE OR THAT ARE REPORTED TO, OBTAINED BY, OR OTHERWISE DISCLOSED TO THE REGULATING ENTITY OR ANY OTHER PERSON IN THE COURSE OF AN EXAMINATION OR INVESTIGATION MADE UNDER THIS TITLE:
 - (I) ARE CONFIDENTIAL MATERIAL;
 - (II) ARE NOT SUBJECT TO SUBPOENA; AND
- (III) MAY NOT BE MADE PUBLIC BY THE REGULATING ENTITY OR ANY OTHER PERSON.
