- (2) BEFORE REMOVING A MEMBER, THE STATE BOARD SHALL SEND THE MEMBER A COPY OF THE CHARGES AGAINST THE MEMBER AND GIVE THE MEMBER AN OPPORTUNITY WITHIN 10 DAYS TO REQUEST A HEARING.
  - (3) IF THE MEMBER REQUESTS A HEARING WITHIN THE 10-DAY PERIOD:
- (I) THE STATE BOARD PROMPTLY SHALL HOLD A HEARING, BUT A HEARING MAY NOT BE SET WITHIN 10 DAYS AFTER THE STATE BOARD SENDS THE MEMBER A NOTICE OF THE HEARING; AND
- (II) THE MEMBER SHALL HAVE AN OPPORTUNITY TO BE HEARD PUBLICLY BEFORE THE STATE BOARD IN THE MEMBER'S OWN DEFENSE, IN PERSON OR BY COUNSEL.
- (4) A MEMBER REMOVED UNDER THIS SUBSECTION HAS THE RIGHT TO A DE NOVO REVIEW OF THE REMOVAL BY THE CIRCUIT COURT FOR FREDERICK COUNTY.

3-5A-02.

- (A) AN INDIVIDUAL WHO IS MARRIED TO AN ADMINISTRATOR OR TEACHER OF THE COUNTY BOARD MAY NOT BE ELECTED TO OR SERVE ON THE COUNTY BOARD.
- (B) AN INDIVIDUAL WHO IS MARRIED TO A MEMBER OF THE COUNTY BOARD MAY NOT BE HIRED AS AN ADMINISTRATOR OR TEACHER BY THE COUNTY BOARD UNLESS THE INDIVIDUAL'S SPOUSE FIRST RESIGNS FROM THE COUNTY BOARD.

  3-5A-03.

AT ITS FIRST MEETING AFTER THE FIRST TUESDAY IN DECEMBER, THE COUNTY BOARD SHALL ELECT A PRESIDENT FROM AMONG ITS MEMBERS.

3-5A-04.

THE PRESIDENT AND THE OTHER MEMBERS ARE ENTITLED TO THE COMPENSATION PROVIDED IN THE FREDERICK COUNTY BUDGET.
3–5A–05.

- (A) ALL ACTIONS OF THE COUNTY BOARD SHALL BE TAKEN AT A PUBLIC MEETING AND A RECORD OF THE MEETING AND ALL ACTIONS SHALL BE MADE PUBLIC.
- (B) THE COUNTY BOARD MAY TAKE ACTIONS IN CLOSED SESSION IN ACCORDANCE WITH § 10–508 OF THE STATE GOVERNMENT ARTICLE.
- SECTION 2. AND BE IT FURTHER ENACTED, That the terms of the appointed members of the Frederick County Board of Education serving on December 4, 2000 shall terminate as follows:
- (a) The terms of appointed members which were scheduled to end on July 1, 2001 or July 1, 2002 shall terminate at the end of December 4, 2000; and
- (b) The terms of appointed members which were scheduled to end on July 1, 2003, July 1, 2004, or July 1, 2005 shall terminate at the end of December 2, 2002.
