AFFILIATION MAY NOT REREGISTER IN THE SAME COUNTY DURING THE SAME PERIOD WITH A PARTY AFFILIATION OR NONAFFILIATION DIFFERENT FROM THE PREVIOUS REGISTRATION.

3-304. CHANGE OF NAME OR ADDRESS.

- (A) NOTIFICATION OF CHANGE OF NAME OR ADDRESS.
- (1) NOTIFICATION OF A CHANGE OF ADDRESS WITHIN THE COUNTY OR OF A CHANGE OF NAME MAY BE MADE:
- (I) BY INFORMATION PROVIDED ON A VOTER REGISTRATION APPLICATION BY THE SAME METHODS PROVIDED FOR REGISTRATION PURSUANT TO SUBTITLE 2 OF THIS TITLE;
- (II) BY WRITTEN NOTICE, SIGNED BY THE VOTER AND SENT BY MAIL OR OTHERWISE DELIVERED TO THE PROPER LOCAL BOARD;
- (III) BY MAKING APPLICATION IN PERSON AT THE OFFICE OF THE LOCAL BOARD;
- (IV) BY INFORMATION ON A VOTER AUTHORITY CARD OR OTHER APPROPRIATE FORM FILLED OUT IN A POLLING PLACE; OR
- (V) BY CHANGING A NAME OR ADDRESS WITH THE MOTOR VEHICLE ADMINISTRATION.
- (2) EXCEPT AS PROVIDED BY REGULATIONS ADOPTED BY THE STATE BOARD, NAME AND ADDRESS CHANGES MAY NOT BE EFFECTED BY THE LOCAL BOARD WHEN REGISTRATION IS CLOSED.
 - (B) PROCESSING REQUESTS FOR NAME AND ADDRESS CHANGE.
- (1) A LOCAL BOARD, PURSUANT TO REGULATIONS ADOPTED BY THE STATE BOARD, SHALL DETERMINE WHETHER A REQUEST FOR A NAME OR ADDRESS CHANGE IS FROM THE REGISTERED VOTER
- (2) IF THE LOCAL BOARD IS SATISFIED THAT THE REQUEST FOR A NAME OR ADDRESS CHANGE IS FROM THE VOTER, THE LOCAL BOARD SHALL CHANGE THE VOTER'S RECORD AND SEND THE VOTER A NEW VOTER NOTIFICATION CARD.

SUBTITLE 4. MUNICIPAL REGISTRATION.

3-401. DEFINITION.

IN THIS SUBTITLE, "UNIVERSAL REGISTRATION" MEANS AN ELECTION ADMINISTRATION IN WHICH THE LIST OF INDIVIDUALS ELIGIBLE TO VOTE IN A MUNICIPAL ELECTION INCLUDES THOSE RESIDENTS OF THE MUNICIPAL CORPORATION WHO ARE REGISTERED TO VOTE WITH THE LOCAL BOARD FOR THE COUNTY IN WHICH THE INDIVIDUAL'S RESIDENCE IS LOCATED.
