- (1) IN BALTIMORE CITY, THE MEMBERS OF THE DEMOCRATIC PARTY CENTRAL COMMITTEE SHALL BE ELECTED FROM THE LEGISLATIVE DISTRICTS OF BALTIMORE CITY AS FOLLOWS:
- (I) FIVE MEMBERS SHALL BE ELECTED FROM THE BALTIMORE CITY PART OF EACH OF THE EIGHT LEGISLATIVE DISTRICTS IN WHICH ALL OR A MAJORITY OF THE POPULATION RESIDES IN BALTIMORE CITY; AND
- (II) ONE MEMBER SHALL BE ELECTED FROM THE BALTIMORE CITY PART OF EACH OF THE TWO LEGISLATIVE DISTRICTS IN WHICH A MINORITY OF THE POPULATION RESIDES IN BALTIMORE CITY.
- (2) (I) THE MEMBERS OF THE REPUBLICAN PARTY CENTRAL COMMITTEE SHALL BE ELECTED FROM EACH CITY COUNCIL DISTRICT OF BALTIMORE CITY.
- $\ensuremath{\text{(II)}}$  FOUR MEMBERS SHALL BE ELECTED FROM EACH CITY COUNCIL DISTRICT.

## (C) BALTIMORE COUNTY.

- (1) EXCEPT AS PROVIDED IN PARAGRAPH (2)(I) OF THIS SUBSECTION, IN BALTIMORE COUNTY, MEMBERS OF THE PARTY CENTRAL COMMITTEES MAY NOT RUN AT LARGE.
- (2) (I) EXCEPT FOR THE CHAIRMAN, THE MEMBERS OF THE REPUBLICAN PARTY CENTRAL COMMITTEE SHALL BE ELECTED FROM THE LEGISLATIVE DISTRICTS OF BALTIMORE COUNTY AS FOLLOWS:
- 1. THREE MEMBERS SHALL BE ELECTED FROM ANY LEGISLATIVE DISTRICT THAT COMPRISES 66% OR MORE OF ITS POPULATION WITHIN BALTIMORE COUNTY:
- 2. TWO MEMBERS SHALL BE ELECTED FROM ANY DISTRICT WHICH COMPRISES MORE THAN 33% BUT LESS THAN 66% OF ITS POPULATION WITHIN BALTIMORE COUNTY:
- 3. ONE MEMBER SHALL BE ELECTED FROM ANY LEGISLATIVE DISTRICT WHICH COMPRISES 33% OR LESS OF ITS POPULATION WITHIN BALTIMORE COUNTY; AND
- 4. IN ANY LEGISLATIVE DISTRICT THAT IS DIVIDED INTO DELEGATE DISTRICTS AND THE DELEGATE DISTRICTS ARE LOCATED ENTIRELY WITHIN BALTIMORE COUNTY:
- A. ONE MEMBER SHALL BE ELECTED FROM A SINGLE MEMBER DELEGATE DISTRICT; AND
- B. TWO MEMBERS SHALL BE ELECTED FROM A TWO MEMBER DELEGATE DISTRICT.
  - (II) THE CHAIRMAN SHALL BE ELECTED AT LARGE.
