13-213. LIMITATIONS ON TRANSFERS.

[26-9]

- (e) (1)] (A) In this subsection, "political committee" includes a political committee registered under § [26-4] 13-202 of this subtitle and an out-of-state political committee.
- [(2)](B) Except as provided in [paragraph (3) of this] subsection (C) OF THIS SECTION, during a 4-year election cycle the treasurer of a political committee or the treasurer of a candidate may not directly or indirectly transfer any money greater than \$6,000 to the treasurer or political committee of a candidate or any other political committee.
- [(3)](C) The limitations on transfers and the provisions on affiliations set forth in this subsection may not apply to:
- [(i)] (1) Transfers between and among political committees that are State or local committees of the same political party;
- $\label{eq:condition} \hbox{\sc [(ii)](2)} \quad \mbox{Transfers between and among a slate and its candidate}$ members; and
- [(iii)] (3) Transfers between a campaign committee authorized by a candidate and that candidate's treasurer.
- [(4)](D) In applying the limitations of this subsection, all affiliated political committees are treated as a single transferor. Political committees are "affiliated" if they are organized and operated in coordination and cooperation with each other or otherwise conduct their operations and make their contribution decisions under the control of the same individual or entity.
- [(5)] (E) The limitations on transfers to the treasurer or political committee of a candidate set forth in [paragraph (2) of this subsection] SUBSECTION (B) OF THIS SECTION shall apply to the individual regardless of the number of offices for which that individual files a certificate of candidacy within a 4-year election cycle.
- [(6)](F) No transfer of any kind, in any amount, is permitted if it is intended to conceal the true identity of the actual contributor or the identity of the intended recipient.

13-214. EXCEPTION TO LIMITATIONS.

[(e-1)] The limitations on transfers and contributions set forth in [subsections (d) and (e) of this section] $\S\S 13-212$ AND 13-213 OF THIS SUBTITLE do not apply to a contribution or transfer made by any person to a ballot issue committee.

[26-10.] 13-215. LIMITATIONS ON FUNDRAISING.

(a) Except as provided in subsection (b) of this section, during a regular session of the General Assembly, the Governor, the Lieutenant Governor, the Attorney General, the Comptroller, a member of the General Assembly, or a person acting on behalf of any of these officeholders, may not:
