AN ACT concerning

Work, Not Welfare Tax Incentive Act - Child Care and or Transportation Expenses

FOR the purpose of extending and amending the Work, Not Welfare Tax Credit to allow a credit against the State income tax, financial institution franchise tax, insurance premium tax, and public service company franchise tax for certain wages paid and certain child care and or transportation expenses incurred by a business entity with respect to certain employees; providing a calculation for the credit; requiring the Department of Legislative Services to conduct a certain study and report to certain committees of the General Assembly; requiring certain units of State government to make certain reports to the Governor and General Assembly; modifying the termination of a certain Act; providing for the application applicability of this Act; and generally relating to a credit against the State income tax for certain wages paid and certain child care and or transportation expenses incurred by a business entity with respect to certain qualified employment opportunity employees.
