INDIRECTLY WITH THE LICENSED PHYSICIAN, THE LICENSED PHYSICIAN IS NOT LIABLE FOR ANY INJURY TO OR CONDITION OF A PATIENT CAUSED SOLELY BY THE NEGLIGENCE OF THE DISPENSER

- (F) A LICENSED PHYSICIAN WHO RELEASES A REPLACEMENT CONTACT LENS PRESCRIPTION TO A PATIENT MAY PROVIDE THE PATIENT WITH A WRITTEN STATEMENT THAT WEARING IMPROPERLY FITTED CONTACT LENSES MAY CAUSE HARM TO THE PATIENTS EYES AND THAT THE PATIENT SHOULD HAVE AN EYE EXAMINATION IF THERE ARE ANY CHANGES IN THE PATIENT'S VISION, INCLUDING PAIN OR VISION LOSS.
- (C) A PERSON WHO DISPENSES REPLACEMENT CONTACT LENSES MAY DISPENSE THEM UPON RECEIPT OF A WRITTEN, VALID, AND UNEXPIRED REPLACEMENT CONTACT LENS PRESCRIPTION.
- $rac{(H)}{(G)}$ $rac{(1)}{(1)}$ A LICENSED PHYSICIAN WHO FILLS <u>OR PROVIDES</u> A CONTACT LENS PRESCRIPTION SHALL MAINTAIN A RECORD OF THAT PRESCRIPTION IN ACCORDANCE WITH § 4–403 OF THE HEALTH GENERAL ARTICLE.
- (2) A PERSON OTHER THAN A LICENSED PHYSICIAN WHO FILLS A CONTACT LENS PRESCRIPTION SHALL MAINTAIN A RECORD OF THAT PRESCRIPTION FOR 5 YEARS.
- (H) THE BOARD MAY IMPOSE A CIVIL FINE OF NO MORE THAN \$1,000 ON A LICENSED PHYSICIAN WHO DISPENSES CONTACT LENSES WITHOUT A REPLACEMENT CONTACT LENS PRESCRIPTION OR FILLS AN EXPIRED REPLACEMENT CONTACT LENS PRESCRIPTION FOR CONTACT LENSES FAILS TO PROVIDE A REPLACEMENT CONTACT LENS PRESCRIPTION OR WHO KNOWINGLY DISPENSES CONTACT LENSES WITHOUT A VALID AND UNEXPIRED REPLACEMENT CONTACT LENS PRESCRIPTION, OR WHO OTHERWISE FAILS TO COMPLY WITH THIS TITLE. 14-608.
- (A) A PERSON MAY NOT SELL OR DISPENSE REPLACEMENT CONTACT LENSES
 BY MAIL WITHOUT A WRITTEN, VALID, AND UNEXPIRED REPLACEMENT CONTACT
 LENS PRESCRIPTION SIGNED BY A LICENSED OPTOMETRIST OR A LICENSED
 PHYSICIAN.
- (B) THE SELLING OR DISPENSING OF REPLACEMENT CONTACT LENSES BY MAIL BY ANY PERSON WITHOUT A WRITTEN, VALID, AND UNEXPIRED REPLACEMENT CONTACT LENS PRESCRIPTION SIGNED BY A LICENSED OPTOMETRIST OR PHYSICIAN SHALL BE CONSIDERED AN UNLAWFUL PRACTICE OF MEDICINE.
- (C) ANY PERSON WHO VIOLATES SUBSECTION (A) OF THIS SECTION IS SUBJECT TO A FINE BY THE STATE BOARD OF PHYSICIAN QUALITY ASSURANCE NOT EXCEEDING \$500 FOR THE FIRST OFFENSE AND NOT EXCEEDING \$1,000 FOR THE SECOND OR SUBSEQUENT OFFENSE.
- (A) KNOWINGLY SELLING OR DISPENSING REPLACEMENT CONTACT LENSES WITHOUT A VALID AND UNEXPIRED REPLACEMENT CONTACT LENS PRESCRIPTION SHALL BE CONSIDERED A VIOLATION OF THIS TITLE.
